RE: Storyboard Request - Harold Rindlisbacher

BACKGROUND:

- The Town of Tecumseh (Town) implemented Storyboard Policy No. 88 (Policy) to provide a streamlined process and guideline for the approval and placement of Storyboard Plaques when the Town receives requests for a Storyboard Plaque to commemorate a significant historical event, person, date, or a physical and natural feature.
- The Cultural & Arts Advisory Committee (CAAC), at the November 21, 2016 reviewed the Storyboard Policy.
- In accordance with the Policy, it is the responsibility of the Applicant, for consideration of a Storyboard Plaque, to provide the following:
 - 1. Applicants must submit a written request to the Director Corporate Services & Clerk for review.
 - 2. The request should outline the purpose and reason for commemoration, and details on size, material, design and instructions on mounting the Plaque.
 - 3. Relevant specifications should be attached with photographs, drawings and any related information to the request submission.
 - 4. Requests should indicate the desired and proposed location of the Plaque in Public Open Space.
- Following receipt of a written submission outlining the purpose and detailed description of the content, design and location of the Plaque to the Director Corporate Services & Clerk, including evidence of background research relevant to the subject of the Plaque, the Director Corporate Services & Clerk will work with other departments to review the submission and consult with committees.
- Following consultation, the Director Corporate Services & Clerk will make recommendations for consideration which will formulate a report to Council for final approval.

- The submission included the necessary information, in accordance with the Policy, as follows:

- Desired Location for story board: Lakewood Park North
- Why?

Most difficult challenge, biggest battle, The only success of the final fight Our father was very pleased with the lakefront park and we feel he would have wanted it there.

• Title:

" Harold Kept Our Community Green " or "He Kept Our Community Green "

- The proposed story, submitted by the Rindlisbacher Family, is attached. Appendix 1
- Consultation is being held with the Planning & Building Services Department and Parks & Recreation Services Department.
- Following full consultations and review, a report and recommendation will be given to Council.
- The cost of the Storyboard is the responsibility of the Applicant.


ACTION REQUIRED:

Appendix 1

Rindlisbacher moved to the St. Clair Beach/Tecumseh area with family in 1966. He loved the green space and view of the Lake. Having grown up in the dry desolate prairies, during the Great Depression, he had a special appreciation for trees, planting thousands over the years. Very early on, he identified with the civic importance of the Lakewood lands to the community.





In 1972, the Spencer family sold the golf course to Sifton Properties of London. When plans quickly arose for development, Harold gathered a group of concerned residents to oppose; they started a petition, collecting hundreds of signatures. Realizing the need for a stronger voice, he ran for council, and won a seat, for the 1973 -74 term. Within time, Sifton was persuaded to drop the plans. The golf course was sold to Joel Jones in 1979. Quietly, Jones talked about partial development during the early 1980's but nothing formal emerged.

Several years later, Jones filed a formal proposal for subdivision of five parcels on Lakewood land (1990). The council of the time compromised in an effort to save the remaining lands as a 9 hole course. But, the north shore (old clubhouse land) was slated for three, six storey, high density, towers. For years, adjoining communities had




prohibited commercial development on the lakeside. Harold and concerned residents mounted an Ontario Municipal Board challenge against Jones and the Village regarding all five parcels. This split the community, with confrontations and bitter feelings.

Harold and the group hired a planner, engineer and one of the finest city lawyers. After three weeks of OMB hearings spread over several months, the final report arrived in the fall of 1992. The only victory; a maximum of three stories on the waterfront weakening the financial viability, no high-rise plans proceeded. When the final bills for the citizens group had to be paid, despite several fund raising efforts, private money had to cover the bulk of costs. Harold's wages were garnisheed for a portion of the costly legal fees. He was re-elected as deputy reeve for his final term 1993 - 94, but it was cut short by open heart surgery with complications. After a long recovery, his family had difficulty keeping him out of the garden and pruning trees in his yard.

Lakewood was sold in 1997, but Jones retained the lakefront property. Tecumseh and St. Clair Beach merged under provincial mandate (1999). Jones pushed ahead with plans for a luxury residential development on the waterfront in 2004. After sometime, the project folded and a portion of land was sold for the Retirement residence. Tecumseh purchased the remaining land on the north shore, and the majority of the course for public parkland in 2010.

With two terms as councillor and three as deputy reeve, old copies of Harold's election flyers show a consistent platform; *Lakewood must be saved as green space for the community*. Rindlisbacher maintained that firm vision, and worked tirelessly for what he believed in.

After repeated attempts to develop it, spanning three decades, surely no one could have imagined parkland for public use – Lakewood Park North, Lakewood Park South. Although he had no actual involvement in its purchase and improvement, without Harold and many hard working residents' early efforts to challenge Lakewood developers, it is very unlikely any of this could have been possible.



Thanks to the vision and actions of Mayor McNamara and Tecumseh town council to acquire this parkland, preserving green space and a beautiful view of the Lake.

RE: Tecumseh Area Historical Society Feather Project - Phase 2

BACKGROUND:

- The Cultural & Arts Advisory Committee (CAAC), in February 2014, was apprised of a grant received by Ms. Julie Butler in cooperation with the Tecumseh Area Historical Society (TAHS) for the creation of wooden feathers.
- The grant application, submitted by the TAHS to the Business for the Arts Program [artsVest] and funded by the Government of Ontario, Ontario Trillium Foundation and Canadian Heritage, was for monies to assist in the creation of wooden feather sculptures depicting specific designs which would be used as markers at significant locations throughout the Town.
- Ms. Butler was successful in obtaining the grant for nine (9) wooden feathers, standing 8' tall, constructed at a cost of approximately \$400 to \$500 for each feather. Local artist Ron Dufault created the feathers. Designs submitted by students from grades 6, 7 and 8 at St. Gregory's School were affixed to the feathers via a shrink-wrap process. Costs affiliated with having the feathers shrink-wrapped were approximately \$3,000.
- Assistance from the Town for the installation of the feathers was requested.
- The CAAC, at the April 28, 2014 meeting, passed the following motion:

THAT the Cultural & Arts Advisory Committee recommend to Council endorsement of the Feather Sculpture Project;

AND THAT the Cultural & Arts Advisory Committee give consideration to including in their annual budget, dollars for the sponsorship of a Feather Sculpture;

AND FURTHER THAT Parks and Recreation Services install the Feather Sculpture at the following locations;

Ward 1: Town Hall - L'Essor - BIA Parkette Tecumseh Area Historical Society - Lacasse Park

Ward 2: Lakewood Park Waterfront

Ward 3: McAuliffe Park

Ward 4: St. Mary's Park - Heritage Park

AND FURTHERMORE THAT the costs affiliated with the installation of the Feather Sculptures be paid for out of the Parks and Recreation Services budget;

AND FURTHERMORE THAT an Unveiling Ceremony be hosted by the Parks and Recreation Services Department along with the Cultural & Arts

Prepared by: Christina Hebert, Deputy Clerk Date: May 29, 2017 Advisory Committee, for the purpose of providing an opportunity for the public to view the sculptures and to acknowledge the efforts of all parties involved in the project;

AND FURTHERMORE THAT a reception be held in conjunction with this unveiling to acknowledge the designation of the Smith Cemetery;

AND FURTHERMORE THAT the Director Parks and Recreation Services provide the Committee with the design and verbiage of the plaques to be installed for their review.

• The nine (9) original feathers were installed at the above-noted locations and an unveiling ceremony was held at Lakewood Park in September 2014.

COMMENTS:

- At the January 16, 2017 CAAC meeting, the Members were informed that the TAHS has grant funds remaining, which will be utilized for additional feathers, anticipated to be completed by the Spring 2017.
- Seven (7) additional feathers are in the final stages of completion.
- The location for the additional seven (7) feathers needs to be determined.
- The Town will continue to provide an in-kind contribution for the installation of the feathers, funded by the Parks & Recreation Services Department.
- The TAHS will allocate remaining grant money to any maintenance costs incurred.

RECOMMENDATION:

- Taking into consideration well-light, high traffic areas for visibility and deterrence from vandalism, the seven (7) new feathers be placed at:
 - Ward 1: Fire Station No. 1 OPP Station Tecumseh Arena
 - Ward 2: Parks Building Manning Road Green Acres Park
 - Ward 3: Rocheleau Park
 - Ward 4: Fire Station No. 2 Walker Road
