And furthermore over that direction **be provided** on Council Member Appointments to the Advisory and Statutory Committees.

Background

The Committee/Local Board Application & Appointment Policy No.4 (Policy) establishes timelines for calling and receiving applications for Committees/Local Boards and a process for reviewing the applications, as well as selecting persons to be appointed to the respective Committees/Local Boards.

The Policy requires that Applications for appointments to the Advisory Committees, Statutory Committee and Local Boards be called in September by the Clerk, in the year of a Municipal Election.

Notice of the call for applications for each of the Advisory Committees, Statutory Committees and Local Boards are to be posted to the Town's website and Facebook page, advertised in the local media, and delivered to the then current Committee or Local Board members.

Advisory Committees provide advice and recommendations to Council, as requested, on areas within their mandate. These Committees have no authority for decision-making, or independent actions. Members are appointed by Council and may include one or two Members of Council and/or a Council Liaison. Examples include:

- Cultural & Arts Advisory Committee;
- Senior Advisory Committee;
- Youth Advisory Committee; and
- Dog Pound.

Statutory Committees are permitted or required by Provincial legislation and perform functions as specified in the relevant legislation. Examples include:

- Committee of Adjustment;
- Property Standards Committee;
- Accessibility Advisory Committee; and
- Heritage Committee.

Comments

In accordance with the Policy, advertisements were placed in the Shoreline Week on September 7, 2018, and in the Essex Free Press on September 6, 2018, requesting Applications from residents desirous of contributing their time and knowledge to serve on the Advisory Committees. The advertisement also sought Applications from residents interested in serving on the Statutory Committees.

A notice was placed on the Town's Website and linked to the Tecumseh Facebook page calling for Applications for each of the above-mentioned Advisory and Statutory Committees, along with a description of each Committee. Emails were sent to all current Committee Members expressing appreciation for their service and inviting them to submit an Application for appointment to a 2019–2022 Committee. A Media Release was broadcast on September 5, 2018, as well as November 8, 2018, about the opportunity to volunteer for a Town Board. The Town's Twitter was also used to notify the public about the call for Applications.

The Policy establishes a deadline for submitting Applications to the Clerk as October 31st annually. Due to a low number of applications, and in some instances insufficient applicants being received by the deadline, an extension was made to November 30th, 2018.

A notice advising of the extension was placed in the Shoreline Week on November 9, 2018 and the Essex Free Press on November 8, 2018, together with a notice placed on the Town's Website and Tecumseh Facebook page.

The Applications for each of the Committees sets out the Eligibility Criteria for applying to a Committee. The Eligibility Criteria states that applicants must be:

- A resident/owner of lands in the Town,
- A Canadian Citizen, and
- At least 18 years old.

Additionally, Applicants may not be an employee of the Town and not prohibited by law from voting in a municipal election.

The Eligibility Criteria for the Tecumseh Accessibility Advisory Committee also includes being a person with a disability. The Youth Advisory Committee Members must be between the ages of 13 and 23; and the Senior Advisory Committee Members must be 60 years or older.

Copies of the Applications received for each of the Committees are available in the Corporate Services & Clerk's Department for viewing.

A brief description of each of the Advisory and Statutory Committees is given in the paragraphs which follow. Tables are also provided which list the current Committee Members, and the names of Applicants for each of the 2019-2022 Committees.

Advisory Committees

Cultural & Arts Advisory Committee

Tecumseh Council established a Cultural & Arts Advisory Committee under the following Terms of Reference:

- identify cultural activities and engagements encouraging community participation (i.e. to promote theatre art, music, visual arts and film);
- obtain artwork depicting local diverse talents and landmarks in addition to the unique features of the Town of Tecumseh, preserving the Town's various histories in the former municipalities of the Town of Tecumseh, Village of St. Clair Beach and Township of Sandwich South, and capturing the essence and spirit of the amalgamated Town;
- identify prominent locations within the Town of Tecumseh for public display of artwork;
 and
- research grants and acquire donations for achieving such goals.

The meetings of the Committee are held monthly on the third Monday of the month at 7:00 pm at Town Hall.

Statutory Committees

Committee of Adjustment

The Committee of Adjustment is responsible for holding hearings under the *Planning Act R.S.O. 1990, c.P.13* (Planning Act) with respect to minor variances to the Town's Zoning Bylaw and applications for consents to severances which result in the creation of a new lot(s) or lot additions.

The *Planning Act* permits the council of the municipality, by by-law, to constitute and appoint a committee of adjustment for the municipality composed of such persons, not fewer than three (3), as the council considers advisable.

The members of the committee who are not members of a municipal council shall hold office for the term of the council that appointed them, and the members of the committee who are members of a municipal council shall be appointed annually.

The Committee of Adjustment for the Town is comprised of seven (7) members from the public and the members are appointed for Council's term of office, in accordance with the *Planning Act.* The past practice by Council, has been to appoint at least one member from each Ward.

Meetings of the Committee are regularly held once a month on the third Monday at 5:00 pm, in the Council Chambers of Tecumseh Town Hall.

Accessibility Advisory Committee

The Ontarians with Disabilities Act (ODA) requires municipalities with a population greater than 10,000 to establish an Accessibility Advisory Committee to advise Council in each year about the preparation, implementation and effectiveness of the municipality's Accessibility Plan, in addition to other obligations as established by the ODA. The ODA requires that not less than 50 percent of the Committee's members be persons with disabilities, or such members as Council deems appropriate.

The Accessibility Advisory Committee (TAAC) normally meets quarterly at 12:00 pm at Town Hall.

Court of Revision

In accordance with Section 97 of the *Drainage Act, R.S.O. 1990 c.D.17 (Drainage Act)*, a Court of Revision shall consist of three (3) or five (5) members appointed by Council. The members of the Court of Revision shall be persons eligible to be elected a member of council, or shall be a member of council.

The purpose of the Court of Revision is set out in Section 52(1) of the *Drainage Act*, which states that an owner of land assessed for the drainage works may appeal to the Court of Revision on any of the following ground:

- 1. Any land or road has been assessed an amount that is too high or too low;
- 2. Any land or road that should have been assessed has not been assessed;
- 3. Due consideration has not been given to the use being made of the land.

The Court of Revision meets as necessary to hear appeals on assessments.

Council adopted the Committee/Local Board Application & Appointment Policy No. 4 (Policy) on February 22, 2011 to establish timelines for calling and receiving applications for Committees/Local Boards and a process for reviewing the applications, as well as selecting persons to be appointed to the respective Committees and Local Boards.

The Policy requires that Applications for appointments to the Advisory Committees, Statutory Committee and Local Boards be called in September by the Clerk, in the year of a Municipal Election. The deadline for applying to a Committee or a Local Board is October 31st annually.

Notice of the call for applications for each of the Advisory Committees, Statutory Committees and Local Boards are to be posted to the Town's website and Facebook page, advertised in the local media, and delivered to the then current Committee or Local Board members.

A notice was placed on the Town's Website and linked to the Tecumseh Facebook page calling for Applications for each of the following Boards:

- BIA Board of Management
- Essex County Library Board
- Essex Power Board
- Tecumseh Police Services Board

Emails were sent to all current Board Members expressing appreciation for their service and inviting them to submit an Application for appointment to a 2019–2022 Committee or Board. A Media Release was broadcast on September 5, 2018, about the opportunity to volunteer for a Town Board. The Town's Twitter was also used to notify the public about the call for Applications. The BIA Coordinator also sent email notifications the business members in the business improvement area.

Due to a low number of applicants, and in some instances insufficient applicants, the deadline for submitting applications was extended to November 30, 2018.

A further notice advising of the extension was placed in the Shoreline Week on November 9, 2018, and the Essex Free Press on November 8, 2018, together with a notice placed on the Town's Website and Tecumseh Facebook page. A News Release was again issued on November 8, 2018, regarding applications being received for Committees and Boards.

The Applications for each of the Boards sets out the Eligibility Criteria for applying to a Board. The Eligibility Criteria states that applicants must be:

- A resident/owner of lands in the Town,
- A Canadian Citizen, and
- At least 18 years old.

Additionally, Applicants may not be an employee of the Town and not prohibited by law from voting in a municipal election.

Applications for the BIA Board of Management also require that persons be: the owner or tenant of commercial lands in the BIA; or an employee of an owner or tenant of commercial lands in the BIA. Employees must provide a letter from the employer in support of their application.

Copies of the Applications received for each of the Boards are available in the Corporate Services & Clerks Department for viewing.

A brief description of each of the Boards is given in the paragraphs which follow. Tables are also provided listing the current Board Members, and the names of Applicants for each of the 2019 - 2022 Boards.

BIA Board of Management

Under Section 204 of the *Municipal Act, 2001*, S.O. 2001 (Act), a municipality is given the authority to designate an area as an improvement area and to establish a Board of Management to oversee the improvement, beautification and maintenance of municipally-owned land, buildings and structures in the area beyond that provided at the expense of the municipality and to promote the area as a business or shopping area.

- 1. The Board of Management is a corporation consisting of the number of directors established by the municipality and is a local board of the municipality for all purposes.
- 2. The Board of Management is to be composed of:
 - One or more directors appointed directly by the municipality; and
 - The remaining directors selected by a vote of the membership of the improvement area and appointed by the municipality.

The term of the directors of a Board of Management is the same as the term of the Council that appointed them, but continues until their successors are appointed. Members of a business improvement area (BIA) consist of persons who are assessed, on the last returned assessment roll, with respect to rateable property in the area that is in a prescribed business property class and tenants of such property.

On November 9, 1999, Council adopted By-law 1999-58 establishing a Business Improvement Area (BIA). At the time, the BIA included the entire geographic limits of the Town.

The Town's BIA has undergone amendments since its 1999 establishment. November 8, 2005, under By-law No. 2005-79, the BIA boundaries were amended to include only the former Town of Tecumseh and Village of St. Clair Beach areas, in addition to a small northerly portion of the former Township of Sandwich South. The amended boundaries reflect the area of the Town where the commercial and shopping districts are more condensed, and excludes properties zoned industrial (i.e.: Bonduelle). In 2016, the BIA boundaries were amended by By-law No. 2016-12 to exempt Beach Grove Golf & Country Club and the properties located south of County Road 22, in the Sylvestre, Jamsyl and Desro Drive areas west of Manning Road,

In accordance with By-law No. 2016-91 the Board of Management is to be comprised of two (2) Directors appointed by Council and seven (7) members of the business improvement area (BIA), who are selected by a vote of the membership.

Council may appoint one or more directors to the Board of Management to act as a liaison between the Board and Council. The Council appointments may or may not be a Member of Council. The member appointments generally represent a number of the diverse commercial services in the BIA.

The BIA Board normally meets on the first Wednesday monthly at 7:00 pm in the Tecumseh Town Hall.

The above applicants **have not been selected** by a vote of the BIA Members. Section 206 of the Act states a board of management shall give reasonable notice to the general membership of the improvement area of a meeting to hold a vote. In light that there are eight (8) qualified eligible applicants, a vote would not be necessary to fill the nine (9) Director position on the Board.

It is recommended that Council approve the qualified applicants for appointment to the Board for the 2019 - 2022 term. Direction is requested on filling the 9th Director position on the Board of Management [temporarily until a BIA member can be found] from among the Members of Council.

Essex County Library Board

The Essex County Library operates a system of 14 branch libraries that provide library materials and services to all residents of Essex County. Its mission of service is that:

"Essex County Library welcomes you to a world of discovery, creativity and lifelong learning through accessible resources, programs and innovative services."

Library facilities are provided by the local municipality with one facility located in each of Amherstburg, LaSalle, Leamington and Tecumseh, three facilities in both Essex and Kingsville, and four in Lakeshore. The hours of operation range from 59 hours a week at the largest branches to 12 at the smallest.

The Essex County Library is funded through the County of Essex, and the Province of Ontario.

The Library Board consists of seven (7) members. Following municipal elections, each local municipality in Essex County, forwards to the County Clerk, the names of potential nominees from their municipality. The Essex County Striking Committee reviews the nominees and makes final recommendations for the Essex County Library Board appointees to County Council for its final approval. The number of County Councillors appointed to the Library Board shall not exceed four (4), in accordance with the *Public Libraries Act* and the remaining three (3) must be lay appointees. The process of how this is accomplished is that each municipality may 'nominate' either their Mayor, or Deputy Mayor, and the name of a lay appointee to the Board. If the Mayor, or Deputy Mayor, are not interested in sitting on the Library Board, then Council need only nominate a lay appointee.

In accordance with the *Public Libraries Act*, the applicant eligibility criteria are as follows:

- Resident, owner or tenant of land in Essex County
- Canadian Citizen
- At least 18 years' old
- Not prohibited by law from voting in a municipal election
- Not an employee of the Essex County Library Board, or the Corporation of the County of Essex

Library Board members are compensated through payment of a stipend for meetings attended and a per kilometre reimbursement for travel to and from meetings.

Library Board meetings are held once a month (except for July and August), usually at 7:00 p.m. on the fourth Wednesday of the month. The Library Board typically meets in the Board Room at the Administrative office located at the Essex Civic and Educational Centre (360 Fairview Avenue West, Essex).

Essex Power Corporation Board of Directors

The Town of Tecumseh, along with the Towns of Amherstburg, LaSalle and the Municipality of Leamington, are the holders of record and the beneficial owners of issued and outstanding common shares in Essex Power Corporation. The municipalities entered into a Unanimous Shareholder Agreement, dated June 1, 2000, regarding certain aspects of the organization of the affairs of Essex Power Corp. and its subsidiaries and their respective rights and obligations to each other.

Article 3 of the Agreement sets out the structure for the Board of Directors and in particular paragraph 3.05 states that each Municipality shall ensure the election, or appointment of Directors, and shall ensure at all times that one of its nominees is an elected municipal representative and that the other nominee is a non-elected member of the business community.

It has been the practice of the Municipalities to appoint their Mayor, or Deputy Mayor, as the elected municipal representative to the Essex Power Board.

The Applications for the Essex Power Board non-elected member of the business community, ask that applicants have an accounting and audit, academic, engineering and/or legal background, as well as experience working on a committee or task force.

Essex Region Conservation Authority Board

The Essex Region Conservation Authority (ERCA) was established in 1973 to manage the natural resources of the Essex Region in partnership with its member municipalities and the Province of Ontario. ERCA is empowered through provincial legislation to further the conservation, restoration, development and management of natural resources other than gas, oil, coal and minerals

 - (d) two persons appointed by the Lieutenant Governor in Council.

Recommendations

It is recommended:

That CS-2018-43 regarding the Council Compensation Review Committee be received;

And that the Terms of Reference, Committee Composition and Name, Scope of Review, as well as the Budget and Administrative Support, for the Council Compensation Review Committee appended to CS 2018-43 in Appendix 1, **be approved**;

And further that consideration be given to appointments to the Council Compensation Review Committee, based on the Committee Composition contained in Appendix 1, from the seven (7) applications received in accordance with the Committee/Board Application & Appointment Policy No. 4.

Background

At the August 14, 2018 meeting of the Policies & Priorities Committee, discussion was held on conducting an independent review of the compensation for Members of Council through a committee and/or consultant.

Direction was given to provide a report on the review and how it will be conducted (PPC-5/18). This report is provided in accordance with that direction.

Comments

Council Remuneration

By-law No. 2006-84 was adopted by Council on November 28, 2006 under the authority of the *Municipal Act, S.O. 2001*, Chapter 25, as amended (Act). Specifically, section 283 provides authority for the council of a municipality to provide payment of remuneration to the members of Council, and such remuneration may be determined in any manner that Council considers advisable. The schedule of By-law No. 2006-84 was subsequently amended by By-law No. 2007-85 on November 27, 2007. These by-laws will be collectively referred to hereafter as the "Remuneration By-law."

The Remuneration By-law sets out the annual remuneration for Council Members as of 2007, and permits an annual increase, each year thereafter, equal to the percentage wage adjustment awarded to non-union employees of the Corporation.

The current annual remuneration for the Mayor and Members of Council is:

Mayor: \$39,047

Deputy Mayor: \$31,650

Councillor: \$24,254

Up to and including 2018, during the term of Council, 1/3 of elected officials' pay was received as a tax-free allowance for income tax purposes. This allowance was meant to offset employment expenses related to carrying out their duties as an elected official and thereby replacing the need to maintain detailed records of business related expenses (which could then be similarly deducted from income for tax purposes). Any expenses above the 1/3 tax-free allowance amount can still be itemized and deducted from taxable income.

The Federal Government, within its 2017 budget, made a change to this allowance, which now stipulates that elected officials are no longer permitted this tax free allowance, beginning in 2019.

In support of the direction of Council at its Policies & Priorities Committee Meeting in August 2018, the impacts of the elimination of the 1/3 tax free allowance should be considered and evaluated relative to the 2019 elected officials' remuneration.

Consideration should be given to the following major impacts:

• Elimination of the 1/3 tax free allowance will result in increased costs to the Town for its share of CPP, and EHT, as well as lost HST recovery. Currently the Town is not required to remit these deductions for the 1/3 tax free share.

- Once the allowance is eliminated in 2019, in accordance with the new Federal guidelines, elected officials' net take home pay will decrease because of higher statutory deductions for CPP. Additionally, annual net pay could also decrease if the employment expenses incurred in any given year (to be deducted by each elected official on their own personal tax return) are below the amount of the 1/3 tax-free allowance that is currently being deducted at the source. The amount of the decrease would depend on each elected official's marginal tax bracket and other deductions that are unique to each elected official.
- Valuable elected officials' time (and likely some municipal administrative time) will need
 to be devoted to maintaining detailed records of employment expenses. These
 expenses may be able to be deducted on an elected official's income tax return.
- Some municipalities have eliminated the tax-free allowance but increased wages in order to ensure the same take home pay for elected officials. This option would increase the Town's costs for wages, as well as statutory employer benefits contributions related to the higher earnings.

As a result of the 1/3 tax free allowance being eliminated, municipalities are considering three options:

- 1. Leave elected officials remuneration status quo;
- 2. Provide additional elected official remuneration to ensure net take home pay remains unchanged; or
- 3. Undertake a full review of elected official remuneration.

As previously mentioned, Council has given direction to undertake a comprehensive review of their compensation in a transparent and accountable manner by way of Committee consultation.

Compensation Review Committee

Administration contacted other municipalities that have reviewed their elected officials' compensation/remuneration by way of Committee for best practices, terms of reference and experience.

Based on the findings from other municipalities, attached as Appendix 1 are the recommended Terms of Reference, Composition and Name of the Committee, Scope of the Review, as well as the Budget and Administrative Support for the Compensation Review Committee.

Applications for the Committee were called, along with other Committee and Board Applications in accordance with the Town's Committee/Local Board Application & Appointment Policy No. 4. Prior to the application deadline, which was extended to Friday, November 30, 2019 for all Committees and Boards, seven (7) applications were received for the Council Compensation Review Committee.

Council Compensation Review Committee

Committee Name and Composition

The Committee shall be referred to as the "Council Compensation Review Committee" and composed of five (5) members. The composition of the Committee shall ideally be comprised of at least:

- One Member with financial experience and educational background; and
- One Member with municipal experience and educational background; and
- Three residents from the Community at-large.

Terms of Reference

To undertake a review of the current level of remuneration/compensation paid to the Mayor and Members of Council, and benefits, including but not limited to:

- health benefits,
- taxation issues (T-2200),
- 1/3 tax-free allowance elimination, and
- the provision of equipment and staffing resources.

The Committee shall make recommendations regarding any proposed changes effective January 1, 2019 for the new term of Council.

The Committee shall submit a final report by the end of July, 2019 outlining any proposed changes to the level of remuneration/compensation and benefits appropriate to the positions of Mayor, Deputy Mayor and Councillor for the new term of office effective January 1, 2019.

After the Committee provides its final report to Council by the end of July of 2019, it shall have met its mandate and be disbanded.

Scope and Nature of the Review

The review shall:

- examine the current work-load and level of responsibility and commitment required of the Mayor and Members of Council;
- determine the adequacy of the current compensations and benefits;
- undertake a review of other peer municipalities, for the purpose of establishing a viable comparative measure; and
- seek feedback and public input as appropriate.

Budget and Administrative Support

The Director Corporate Services & Clerk shall provide administrative support and be responsible for associated costs related to supporting the Council Compensation Review Committee, including a third-party consultant. Funding shall be provided within the 2019 Budget and the Clerk is authorized to direct the allocation of the 2019 Budget and personnel to support the work of the Committee.

The Director Financial Services & Treasurer shall provide support related to the financial impacts and costing of remuneration alternatives.

Background

The Awards Policy No. 2 (Policy) was first approved on February 22, 2011. The Policy establishes processes and timelines for submitting nominations and selecting recipients each year for the Donny Massender Award, Dr. Henri Breault Community Excellence Award and the Senior of the Year Award (collectively hereinafter referred to as Awards).

The Policy includes a provision for the recipient of the annual Donny Massender Award to be nominated for the Provincial June Callwood Outstanding Achievement Award for Volunteerism in Ontario and the Ontario Medal for Good Citizenship.

The annual recipient of the Senior of the Year Award is nominated for the Ontario Senior of the Year Award and the Senior Achievement Award (Canada).

Oversight of the Policy and the calling of nominations is the responsibility of the Corporate Services & Clerk's Department.

Traditionally, a Volunteer Appreciation Night has been held to acknowledge the dedication and commitment of the Town's committee and board members. It has also served as a venue to present these annual Awards.

In 2019, Volunteers and Award recipients will be recognized at an event being planned during National Volunteer Week in the month of April.

Comments

In accordance with the Policy, Notices of the Call for Nominations for each of the Awards were placed in the Essex Free Press (September 6, 2018 and November 8, 2018) and Shoreline Week (September 7, 2018 and November 9, 2018) in addition to being posted on the Town's website, social media (Facebook and Twitter) and Tecumseh Town App. Additionally, the Notice was mailed directly to local charitable and non-profit organizations on October 4, 2018.

The Policy establishes a deadline for submitting Nominations to the Clerk as October 31 annually. This deadline was extended to November 30, 2018 as per Report CS-2018-37 Committee and Board Application and Award Nominations, which was adopted at the November 13, 2018 Regular Council Meeting.
