needs. The affects of the secondary planning area was reviewed. A number of culverts are recommended for improvements.

Mr. Wally Antovski, 12344 Charlene Lane

Mr. Antovski attended a meeting regarding flooding and notes it has taken a long time to address these issues. Residents should not be responsible for the cost. He acknowledges the unusual weather affects.

The Director Public Works & Environmental Services advises the immediate action undertaken by the Town on cleaning out the Baillargeon Drain between Lesperance and Manning Roads. He notes that these improvements to the drains and stormwater systems are designed for certain types of rain events, such as a two or five year storm event, not for the significant rain events that occurred in 2016. There is a Flood Mitigation Strategy endorsed by Council, and a Storm Drainage Master Plan is initiated to help further address future needs. During the larger rain events, water is designed to sit on the roads but should not exceed a certain height, and will be otherwise redirected. There has been a number of Public Information Centres on flooding, and the Storm Drainage Master Plan is expected to be finalized in the next few months.

Paul Adams, 2392 Lesperance Road

Mr. Adams does not fully support the subject report. His property backs on to the Antaya Drain. Based on the location of the drainage ditch, he believe there is more land draining in the Antaya Drain and that the East Townline Drain drainage area should be increased t include these areas. He does not see perceived or direct benefit and questions how he has been assessed. He understands the *Drainage Act* and his financial obligations; however, everyone should be assessed fairly.

Mr. Hernandez advises that he is working on a report on the Antaya Drain and acknowledges Mr. Adams' concerns. There can be drains that use other drains to move stormwater to an outlet. Residents can be assessed benefit from more than one drain.

Mr. Adams understands the proposed works will be completed in stages. He feels residents on Strawberry Drive will benefit, and should be included in the report.

Mr. Hernandez advises reports are prepared on a level of balance, and based on previous reports. There is quite an accumulation of costs on this drain and to have affected owners further explored would increase costs to this report.

Councillor Brian Houston notes that there are 600 homes assessed in Block C of this report. He suggests that residents in Block C contact Drainage Superintendent Sam Paglia if they have any questions regarding their assessment.

John Valle, 2048 St Anne Street

Mr. Valle lives in Block C of the assessment. Most of the proposed work is being done along Highway 22. He questions why he is being assessed when the works do not affect him. He cannot use one-third of his yard due to flooding and the clay soil. He questions why he is being assessed when his lands are not draining. He suggests 'drain pits' be installed to prevent flooding.

The Director Public Works & Environmental Services explains the drainage on St. Anne's Street, the limitations of the existing infrastructure and the impending improvements that are required. In response to a query regarding timelines, he advises on how the priority of projects is determined in coordination with other capital improvements.

Mr. Antovski inquires on the timelines for the Storm Drainage Master Plan regarding what works will be done immediately rather than in future years. The Director Public Works & Environmental Services reiterates the drainage work and

the Storm Drainage Master Plan. The Town also has a basement flooding subsidy program to assist residents with protecting their property.





I am pleased to inform you that, in accordance with the commitment in Budget 2019, the Government of Canada will provide an additional \$2.2 billion to the Gas Tax Fund. The gas tax top-up funding is expected to be transferred following royal assent of Budget 2019.

- \$250 million for infrastructure in rural and northern communities.

The one-time top-up to the Gas Tax Fund adds substantial dollars to this Agreement. More importantly, those dollars flow to you.

We believe this is an important step to take to ensure your local priorities have the resources needed so projects can get moving and, crucially, the summer construction season is not missed. We all know how important that season is to make real progress on projects, not to mention job creation locally.

In the meantime, we continue to press the Ontario government to open intakes for all four streams so as to maximize the number of projects we can build together for Ontarians in 2019 and the years ahead.

We know you have proposals ready, and last week's announcement in Budget 2019 is a clear signal that we are there to support you.

THE FEDERAL GAS TAX FUND IN ONTARIO

The federal Gas Tax Fund delivers over \$2 billion every year to over 3600 communities across the country. For the 2018-19 fiscal year, this represents an investment of more than \$819 million from the Government of Canada to Ontario municipalities.

The federal Gas Tax Fund (GTF) is a permanent source of annual funding to provinces and territories, who in turn flow this funding to their municipalities to support local infrastructure priorities.

Every year, municipalities benefit from the support and flexibility of the federal Gas Tax Fund. They can pool, bank, and borrow against this funding — providing significant financial flexibility to plan infrastructure projects over the long term. Projects are chosen locally and prioritized according to the infrastructure needs of each community.

Communities select how best to direct the funds and have the flexibility to make strategic investments across 18 different project categories.

Because many municipalities across Canada continue to face serious infrastructure deficits, **Budget 2019** proposes a **one-time transfer of \$2.2 billion** through the federal Gas Tax Fund to address short-term priorities in municipalities and First Nations communities. This will double the Government of Canada's commitment to municipalities in 2018–19, with **Ontario municipalities of all sizes sharing an additional federal investment in local infrastructure of over \$819 million, for a total of approximately \$1.64 billion.**

OUICK FACTS:

- The federal Gas Tax Fund is allocated on a per capita basis for provinces, and provides a base funding amount of 0.75 percent of total annual funding for Prince Edward Island and each territory.
- On-reserve First Nations communities in provinces also receive an allocation on a per capita basis.
- The federal Gas Tax Fund has been indexed at two percent per year, meaning that it will continue to grow to provide additional support to municipalities.
- To date, more than \$23 billion has been invested in municipalities through the federal Gas Tax Fund.



THE FEDERAL GAS TAX FUND

Eligible projects include investments in infrastructure for construction, renewal or material enhancement in each of the following categories:











- Local roads and bridges roads, bridges and active transportation infrastructure (active
 transportation refers to investments that support active methods of travel. This can include: cycling
 lanes and paths, sidewalks, hiking and walking trails).
- 2. **Highways** highway infrastructure.
- 3. **Short-sea shipping** infrastructure related to the movement of cargo and passengers around the coast and on inland waterways.

- 12. **Brownfield redevelopment** remediation or decontamination and redevelopment of a brownfield site
- 13. **Sport infrastructure** amateur sport infrastructure (excludes facilities, including arenas, which would be used as the home of professional sports teams or major junior hockey teams, e.g. Junior A).
- 14. Recreational infrastructure recreational facilities or networks.
- 15. Cultural infrastructure infrastructure that supports arts, humanities, and heritage.
- 16. **Tourism infrastructure** infrastructure that attracts travelers for recreation, leisure, business or other purposes.
- 17. **Disaster mitigation** infrastructure that reduces or eliminates the long-term impacts and risks associated with natural disasters.
- 18. Capacity building investments related to strengthening the ability of municipalities to develop long-term planning practices (e.g., including local asset management planning, public transit network planning, etc.)

6.4 COUNCIL REPORT - Councilor Dowie reports on some of the items on the January 15, 2019 Council's meeting:

- Public Council Meeting address the proposed Bicycle Lanes on Lesperance Road from Riverside to McNorton. The lanes would be added by removing the paint from Lesperance Road and eliminating the continuous centre left turn lane. Left turn lanes would be retained at Riverside Drive and at McNorton Street. Because most of the cost is covered by a provincial grant and the County's CWATS fund, the impact to the municipality is \$11,500. The engineering consultants reviewed resident concerns and responded with the best opportunities for risk mitigation where warranted. They did encourage that pre-existing concerns for speeding and for poor stopping habits of drivers be referred to the Ontario Provincial Police for enforcement.
- Opting in to Allow Retail Cannabis Stores. Niagara Falls is requesting that the Province give municipalities greater regulatory controls over the location, distance separations and numbers of Retail Cannabis Stores within a municipality. Town of Tecumseh opts out of Cannabis stores.
- Fluoridation of Water Supply. Administration is recommending that no action be taken until legal opinions and notification of decision by the City of Windsor is made.
- Taxes Receivable December 2018. Administration supplies an update with respect to tax arrears indicating a decline in the number of residential and industrial properties in arrears and increase in commercial properties in arrears (although the value of the industrial arrears is increasing. There is a total of 600 properties in arrears having a value of \$2,203,000.
- Tecumseh Transit Service, 2018 Review. Administration advises that ridership has stagnated with a slight increase noted in 2018. The system appears to have peaked at its current ridership levels based on current route design. Tecumseh Mall and Southfield/Tecumseh remain the most popular stops for riders. Discussions surrounding further coordination with Transit Windsor have also been initiated.
- Planning & Building Services 2018 Year End Permit Report. There has been a reduction in new residential building
 activity from 2017 but an increase of additions and renovations. Revenues from new buildings exceeded
 expectations.
- Notice of Decision for Official Plan Amendment No. 15 Village of St. Clair Beach Official Plan 14328 and 14346
 Tecumseh Road. Essex County advises that it has approved the Harbour Club Condominiums at Pud's Place
 Marina.
- In support of SouthWestern Integrated Fibre Technology's request to modify the Canadian Radio-Television and Telecommunications Commission (CRTC) Broadband Funding Model. Mayor McNamara and CAO Tony Haddad submitted letters requesting a rebalancing of funding for broadband implementation to include areas in Southwestern Ontario.

Recommendations

It is recommended:

That Report CS-2019-08 regarding the MADD Campaign 911 Program (Program) **be received**:

And that MADD **be permitted** to install Program signs at the entrances to the Town of Tecumseh (Town) from Windsor on Tecumseh Road and Riverside Drive, as well as the entrance and exits of the Town on County Road 22, along with County Road 11 and County Road 19, subject to the approval of the County of Essex;

And further that MADD Windsor & Essex County **be granted** licensing privileges under the Use of Official Mark Policy 51 to permit the use of the Town's Official Mark on their Program signs;

And further that the Mayor and Clerk **be authorized** to execute a Trademark Agreement with MADD Windsor and Essex County to permit the Town's Official Mark on the Program signs.

Background

The MADD Campaign 911 Program (Program) was launched in 2007 nationwide to encourage residents to help make roads safe and reduce the number of deaths caused from impaired driving. The Program's focus is community outreach using roadside signage, urging residents to report suspected impaired drivers by calling 911 to alert police before a potentially fatal accident occurs.

MADD Windsor and Essex County (MADD) reports the national results of this Program are effective in the prevention of impaired driving deaths including 911 calls increased 45 to 80 percent in the first year of the Program's implementation in a municipality; roadside licence suspensions increased 30 to 80 percent and; local enforcement interception rates ranged from 40 to 50 percent.

The City of Windsor implemented this Program in 2008, with 42 signs installed around the City.

In Fall 2018, with the support of Caesars Windsor Cares, MADD received additional funding to refresh the sign's artwork, enlarge sign size, and to deliver the Program across Essex County. MADD has approached area municipalities for support of this Program, as well as the Tecumseh OPP [Attachment 1]. At the writing of this report, The Towns of LaSalle and Amherstburg and the Municipality of Leamington have formally supported this Program in their respective municipalities.

Comments

In consultation with the Planning & Building Services and the Public Works & Environmental Services Departments, MADD is requesting to install ten (10) signs in the Town of Tecumseh; two (2) signs along roads that are under the jurisdiction of the Town, and eight (8) signs along roads under the jurisdiction of the County of Essex. Administration has recommended that the signs be installed at the entrances to the Town from Windsor on Tecumseh Road and Riverside Drive. The other suggested locations are at the entrance and exits of the Town on County Road 22, along with County Road 11 and County Road 19. MADD will seek County approval for the sign locations on County roads within the municipality.

The signs are available in two sizes: 24-inches by 30-inches and the larger ones are 4-feet by 8-feet. Each sign will include the Police logo (OPP), MADD logo, and the Town of Tecumseh official mark (Logo). The draft artwork of the sign to be installed in the Town is attached. [Attachment 2 & 3]

Sign By-law No. 2018-33 (Sign By-law) currently establishes that no person shall erect a sign on any Municipal, County or Provincial highway or right-of-way. However, the Sign By-law establishes that Council may permit any sign within the Town that does not otherwise comply with the provisions of the Sign By-law. The current request is for the display of signs that communicate information that we believe will benefit the public at large. MADD (acronym for Mothers Against Dunk Driving) is a well recognized organization that has a history of changing societal attitudes regarding the tragic consequences of drinking and driving. The information portrayed is, we believe, for the public good and therefore consistent with the broader objectives of the Sign By-law.

In accordance with By-law No. 2003-20 and the Use of Official Mark Policy 51 (Policy), as a precondition to the use of the Town of Tecumseh's official mark or trademark, the approval of Council is required. The use of the official mark is restricted to all "Departments, Committees of Council, and Boards affiliated with the Town." As MADD is not affiliated with the Town, the Policy indicates that Council may use its discretion to grant licensing privileges to an organization as a community project in order to use the official mark.

It is recommended that MADD Windsor & Essex County be granted licensing privileges as a community project and that the Mayor and Clerk be authorized to execute a trademark agreement with MADD for use of the Town's official mark on their 911 campaign signs.

Subject: Fluoridation of Water

Recommendations

And that By-law No. 2019-xx authorizing fluoridation of drinking water, in accordance with the Fluoridation Act, R.S.O. 1990 c.F.22, **be considered**.

Background

Report CS-2019-02 regarding fluoridation of water supply was presented to Council at their Regular Meeting held on February 12, 2019. At the meeting Council passed Resolution No. RCM-24/19 directing a further report be provided after receiving:

- legal advice on the interpretation and application of the Fluoridation Act,
- the history of fluoridation of drinking water in the Town of Tecumseh, and
- the City of Windsor's position on next steps in the process.

Comments

This report is being provided in accordance with the February 12, 2019, direction by Council.

Legal Advice

A closed meeting of Council has been scheduled for Tuesday, April 9, 2019, at 5:00 pm as permitted under Section 239 (2)(f) of the Municipal Act, 2001, which permits a meeting, or part of a meeting, to convene in closed session when the subject matter to be considered is subject to solicitor-client privilege, including communications necessary for that purpose.

The Town's Solicitor will be in attendance at the meeting to present his opinion and advice on the interpretation and application of the Fluoridation Act, R.S.O. 1990 c.F.22.

History of Fluoridation of Water

The Town of Tecumseh (Tecumseh), the Windsor Utilities Commission (WUC) and the City of Windsor (City) entered into a Water Servicing Agreement on November 10, 2004, and a subsequent Amending Agreement on January 16, 2006 (hereafter collectively referred to as "Agreement"). The Agreement provides Tecumseh with a secure source of drinking water for a period of fifty (50) years.

Prior to WUC's supply of water to all of Tecumseh under the Agreement, Tecumseh's water distribution network historically consisted of two distinct service areas:

- the North Tecumseh Service Area (north of Highway 401) which includes the urban settlement areas of Tecumseh, St Clair Beach and Tecumseh Hamlet which was serviced by a Windsor-Tecumseh Joint Waterworks Board; and
- ii. the South Tecumseh Service area (south of Highway 401) which includes urban settlement areas of the Oldcastle Hamlet and the Maidstone Hamlet which were serviced by WUC.

In the North Service Area, a review of historical records suggests that fluoridation was introduced in 1969 (third reading of Tecumseh By-law 942) regarding the joint system for Windsor and Tecumseh. It would appear that fluoridation was eventually removed at some point prior to December 17, 1998, as there is record of a by-law then being enacted by the Town of Tecumseh to again establish, maintain and operate a fluoridation system.

On or about December 7, 2001, the fluoridation equipment was placed off-line for regulatory reasons. Council resolved in May of 2003, following a March 30, 2003, Report from the Town's Director of Water and an April 8, 2003, Public Meeting, not to refer the question of discontinuing fluoridation to the electorate and to proceed with necessary upgrades to the fluoridation equipment. In 2004, the Town entered into the Agreement with WUC for its water supply, rather than proceed with upgrades to its own system.

The South Service Area, as noted above, has been supplied by WUC/Windsor for a number of years pre-dating the Agreement with WUC. It is understood that on or about October 16, 1961,

Windsor passed a by-law to require the establishment of a fluoridation system in connection with the WUC system.

Fluoridation was last dealt with in 2012/2013 where, following the decision of Windsor City Council on January 28, 2013, and adoption of City By-law 20-2013, WUC made application to the Ministry of the Environment (MOE) to amend its licence to remove fluoride from the WUC water supply. WUC was made aware that Tecumseh had passed a resolution on February 29, 2012, to support the cessation of fluoridation and cited same in a report to Windsor City Council. However, neither the Town of Tecumseh, nor the Town of LaSalle, nor the Town of Lakeshore's by-law approving this action was sought by WUC in advance of WUC proceeding in 2013 with its application to the MOE.

City of Windsor

The City Council at its March 25, 2019, meeting passed By-law 35-2019, repealing By-law 20-2013 and "requiring fluoridation of the water supply for The Corporation of the City of Windsor, pursuant to the Fluoridation Act."

Discussion

The Province of Ontario has left the determination of whether to add fluoride to the water supply to each individual municipality, pursuant to the Fluoridation Act.

In December 2018, City Council directed the introduction of fluoride (Decision Number: CR676/2018). As a result, the application of the Fluoridation Act was activated.

WUC operates a joint waterworks system for the City and the Towns of Tecumseh and LaSalle.

In accordance with the provisions of the Fluoridation Act regarding the introduction of fluoride to the water supply, the majority of the participating municipalities in a joint waterworks must pass a by-law requiring same.

The City of Windsor passed By-law 35-2019.

In the Report to City Council from its Administration (Council Report C47/2019) it is noted that "While Windsor cannot force LaSalle and Tecumseh to address the issue of fluoride, the bylaw will be provided to them by the Clerk upon its passing."

Formal communication from the City Clerk's office has not yet been received as the writing of this report. However, in accordance with the direction of Tecumseh Council, this report and attached draft By-law are being provided.

In order for WUC to proceed with the addition of fluoride, it must receive an authorizing by-law from at least two of the municipalities for which it provides a waterworks system – the City, Tecumseh and LaSalle.

The Town of LaSalle does not currently have the matter scheduled to go before its Council, pending a formal request from the City of Windsor.

The costs and rates of water supplied by WUC are captured within the provisions of the Water Servicing Agreement between the Town and WUC. These provisions are currently being clarified through Mediation/Arbitration.

And Whereas in accordance with the Fluoridation Act, R.S.O. 1990 c. F.22 the Council for The Corporation of the Town of Tecumseh has deemed it desirable to authorize WUC to establish, maintain and operate a fluoridation system to add fluoride to the water supply for The Corporation of the Town of Tecumseh;

Now Therefore the Council of The Corporation of The Town of Tecumseh Enacts as follows:

- 1. **That** the Council for The Corporation of the Town of Tecumseh hereby requires fluoridation of the water supply for The Corporation of the Town of Tecumseh in accordance with the Fluoridation Act, R.S.O. 1990 c. F.22.
- 2. **That** this by-law shall come into force and take effect on the day of final passing.

1. **That** the scheduling of a public meeting, to be held on Tuesday, May 14, 2019 at 5:00 p.m., in accordance with the *Planning Act* for a Zoning By-law Amendment application seeking to amend the former Town of Tecumseh Zoning By-law 1746 by rezoning a 1251 square metre (13,465 square foot) parcel of land situated on the north side of Riverside Drive, approximately 290 metres west of its intersection with Manning Road (13214 Riverside Drive), from "Residential Zone 1 (R1)" to a site specific "Residential Zone 1 (R1-11)" to permit the construction of a detached accessory garage with a second storey dwelling unit on the subject property in addition to one detached dwelling unit, **be authorized**.

Background

Subject Property and Surrounding Land Uses

Mr. David Halliwill ("the Applicant") has filed an application with the Town to amend the Tecumseh Zoning By-law 1746 for a 1251 square metre (13,465 square foot) parcel of land situated on the north side of Riverside Drive, approximately 290 metres west of its intersection with Manning Road (13214 Riverside Drive). The subject property has a frontage of 15.3

metres (50.5 feet) on Riverside Drive and a total lot area of approximately 1251 square metres (13,465 square feet). The property is currently occupied by a single-unit residential dwelling located centrally on the property and a detached garage that is located on the southerly portion of the property, abutting the north side of Riverside Drive. An existing municipal sidewalk is situated across the front of the property on the north side of Riverside Drive and Lake St. Clair abuts the property to the north (see Attachment 1).

The lakefront residential properties on the north side of Riverside Drive are characterized by single-unit dwellings that are gradually redeveloping/transitioning to larger, newer homes. In addition, several properties in the general vicinity of the subject property contain accessory detached garages in the front yard, abutting the north side of Riverside Drive (see Attachment 2).

Proposal Details

The purpose of the application is to request that the property be rezoned to permit the construction of a detached garage that will include a second-storey dwelling unit. The applicant has indicated that the second dwelling unit is intended for his mother-in-law. The applicant is proposing to demolish the existing buildings on the property in early April of 2019 in order to facilitate the construction of a new single-unit dwelling and the proposed detached garage with a second storey dwelling unit. The proposed new buildings will be located in the same general location as those that currently occupy the property (see Attachments 3A and 3B for site plan and proposed accessory structure elevations).

The proposed single-unit detached dwelling complies with the current Residential Zone 1 (R1) zoning of the property. The R1 zone, however, does not currently permit the proposed second dwelling unit above the detached garage.

Accordingly, a rezoning application has been filed with the Town seeking to rezone the lands into a site-specific residential zone that would:

- permit the aforementioned second dwelling unit in the second storey of the detached garage;
- establish a minimum front yard depth of 5.18 metres (17 feet) for the detached garage/second dwelling unit structure, rather than the current minimum of 7.6 metres (25 feet); and
- establish a maximum area of 79 square metres (850 square feet) for the proposed detached garage/second dwelling unit structure, rather than the current maximum of 70 square metres (753 square feet).

Comments

Provincial Policy Statement

The Planning Act establishes that Council, when making decisions that affect a planning matter, "shall be consistent with" the 2014 Provincial Policy Statement ("PPS") issued under the Planning Act.

There are a number of policies within the PPS that support the proposed application for the proposed second unit. The following are the relevant excerpts from the PPS:

- "1.1 Managing and Directing Land Use to Achieve Efficient and Resilient Development and Land Use Patterns
 - 1.1.1 Healthy, liveable and safe communities are sustained by:
 - a) promoting efficient development and land use patterns which sustain the financial well-being of the Province and municipalities over the long term;
 - b) accommodating an appropriate range and mix of residential (including second units, affordable housing and housing for older persons)...; and

. . .

- e) promoting cost-effective development patterns and standards to minimize land consumption and servicing cost.
- 1.1.2 Sufficient land shall be made available to accommodate an appropriate range and mix of land uses to meet projected needs for a time horizon of up to 20 years...

Within settlement areas, sufficient land shall be made available through intensification and redevelopment ...

1.1.3 Settlement Areas

- 1.1.3.1 Settlement areas shall be the focus of growth and development, and their vitality and regeneration shall be promoted.

- all forms of residential intensification, including second units, and redevelopment in accordance with policy 1.1.3.3;
- promoting densities for new housing which efficiently use land, resources, infrastructure and public service facilities, and support the use of active transportation and transit in areas where it exists or is to be developed; and
- d) establishing development standards for residential intensification, redevelopment and new residential development which minimize the cost of housing and facilitate compact form, while maintaining appropriate levels of public health and safety.

6.0 Definitions

Residential intensification: means intensification of a property, site or area which results in a net increase in residential units or accommodation and includes:

- redevelopment, including the redevelopment of brownfield sites;
- b) the development of vacant or underutilized lots within previously developed areas;
- c) infill development"

In summary, the PPS encourages and supports development on lands identified for urban growth in settlement areas. It also establishes that the Town should be supporting and promoting residential infill development that results in a compact built form and makes more efficient use of existing services while offering a broad range of housing forms/types to meet expected needs.

The subject proposal is in a location and of a form of residential development that is in keeping with the foregoing policy objectives. The PPS specifically encourages second unit dwellings as a means to accommodating a range and mix of residential uses. This proposal provides an alternative form of housing at a density that provides for a more compact built form. The proposed development is also considered to be intensification in accordance with the definition

contained in the PPS. Based on the foregoing, it is the opinion of the writer that the proposed second dwelling unit dwelling above the detached garage is consistent with the PPS.

County of Essex Official Plan

The subject property is within an identified settlement area of the County of Essex Official Plan ("County OP"). The goals and policies of the County OP encourage a range of residential development within identified settlement areas such as the fully serviced urban areas of the Town of Tecumseh. The following goals and policies of the County OP are most relevant in the assessment of the subject proposal:

"3.2.3 Policies

The following policies are established for those lands shown as Settlement Areas on Schedule "A":

. . .

f) local Official Plans are encouraged to provide opportunities for redevelopment, intensification and revitalization in areas that have sufficient existing or planned infrastructure;

. .

- h) local Official Plans are encouraged to provide for a full range of housing types and densities to meet projected demographic and market requirements of current and future residents of the housing market by:
 - iv) encouraging all forms of residential intensification in parts of built up areas that have sufficient existing or planned infrastructure to create a potential supply of new housing units available from residential intensification."

The proposed second unit dwelling above the detached garage conforms to the aforementioned goals and policies of the County OP.

Tecumseh Official Plan

The subject property is currently designated "Residential" in the Tecumseh Official Plan ("Tecumseh OP") (see Attachment 4). The Tecumseh OP encourages a variety of densities of residential uses that can be appropriately integrated with the existing and proposed development pattern by meeting the applicable policies of the Plan.

The following sections from the Tecumseh OP are relevant when reviewing the subject development applications:

 - b) To encourage new residential development to occur in such a manner which makes the most efficient use of municipal infrastructure and services, in keeping with the capacity of the existing services available and the financial ability of the municipality to provide the required additional infrastructure and services.

. . .

d) To broaden the range of housing options available to existing and future residents of the Town, by encouraging the continued production of a diverse and affordable mix of housing that is capable of meeting the needs of all households – including low and moderate income households and households with special needs. The provision of a mixture of housing forms, sizes, tenures and affordable housing types, including both public and private sector sponsored housing are to be encouraged.

Land Use Policy, Residential

- 3.3.1 The lands designated Residential shall be used primarily for residential purposes. Various types of residential dwellings shall be permitted within this designation, provided they meet all of the applicable policies of this Plan. The regulations and zone provisions of the town's comprehensive zoning by-law implementing this Plan shall be in accordance with the following:
 - (i) Low Density Residential Uses

The maximum permitted density within any Low Density Residential Zone shall be 18 units per net hectare. Permitted residential uses shall consist of single-unit detached dwellings and single-unit attached dwellings.

3.3.7 The Town will encourage the production of a wide range of housing types and tenures (including assisted housing) that will meet the future needs of all households, and are affordable to households of all income levels...".

Council will work with both private and public sector developers, builders and agencies so that sufficient market-oriented and assisted housing is produced to meet the existing and anticipated future needs of family, senior and non-family households.

3.3.8 In the Town of Tecumseh, Council will encourage both public and private sector landowners, developers and builders to undertake small-scale infilling type residential intensification activities that make the most efficient and cost-effective use of existing municipal infrastructure and services. Infilling means the residential development of a similar scale, density and use on vacant lots or undeveloped lands in the built-up area of the municipality, to create additional dwelling units.

When reviewing individual requests for residential intensification initiatives, Council will have regard to the following:

- the height, size, and density of the new dwelling unit(s), and the compatibility of such unit(s) with the surrounding neighbourhood;
- the physical suitability of the site;
- the proximity of the site to public transit and commercial retail areas;
- access to and from the site;
- availability and proximity of community services such as community and day care centres, schools, parks, and leisure activities, and health care services;
- adequacy of municipal infrastructure to service the new unit(s)."

The proposed second dwelling unit above the detached garage is in keeping with the aforementioned objectives and policies of the Tecumseh OP in terms of broadening the range of housing types. It also satisfies the above-noted criteria for infilling type residential intensification activity. The proposed dwelling unit will not result in measurable traffic flow increases on local streets in the area and adequate off-street parking and access is proposed.

The resulting two dwelling units on one property proposed through this application equate to a density of 16 units per net hectare which is within the threshold to be considered low density development. In terms of the proposal's compatibility with the surrounding area, it is has been noted earlier in this Report that accessory detached garages located in the front yard, abutting Riverside Drive, are common for residential properties along the north side of Riverside Drive within the former Town of Tecumseh urban area. According to municipal records, 43

residential properties within the surrounding area contain an accessory structure abutting Riverside Drive. Although the majority of the existing detached garages in the area are single storey, there are a number that are similar in size and scale to the proposed detached structure. It should also be noted that the proposed detached structure will have architectural details consistent with the proposed new house on the subject property. Based on the foregoing, it appears that the addition of a second dwelling unit above the proposed detached garage will create a development pattern and built form that is in keeping with the character of the neighbourhood.

The subject property is within a short walking distance of a Tecumseh Transit Service stop to the east along Riverside Drive. This service provides a direct connection to a major commercial node to the south in the vicinity of the Manning Road/Tecumseh Road intersection. It is also within walking distance of Lakewood Park and Piqua Park and the broader neighbourhood is serviced by a number of schools.

Accordingly, it is the opinion of Administration that, based upon our preliminary review, the proposed second dwelling unit above the detached garage conforms to the Tecumseh OP.

Tecumseh Zoning By-law 1746

The subject property is currently zoned "Residential Zone 1 (R1)" in the Tecumseh Zoning Bylaw 1746 (see Attachment 5). The current R1 zoning permits one single unit detached dwelling on one lot and accessory buildings and structures. The proposed Zoning By-law amendment places the subject property into a site specific Residential Zone 1 (R1-11) that would facilitate the proposed second dwelling unit above the detached garage and establish site-specific minimum yard and maximum building size requirements for the proposed detached garage/second dwelling unit structure.

It should be noted that only a small portion of the proposed detached garage/second dwelling unit structure (ie. the south-western corner) will have a front yard depth of 5.18 metres (17 feet). The majority of the structure will comply with the current minimum front yard depth of 7.6 metres (25 feet). The proposed location of the detached garage/second dwelling unit structure is intended to maintain an adequate distance between it and the proposed single unit dwelling on the subject property.

Building Services

Building Services have advised that it has no concerns with the redevelopment of the property.

Engineering/Municipal Services

The proposed second dwelling unit above the detached garage will be serviced with full municipal services (ie. service connections for water, sanitary and stormwater services). Public Works and Environmental Services have no concerns with the redevelopment of the property for the proposed residential uses.

Conclusion

Having regard to the range, scale, location and nature of surrounding uses, the suitability of the subject property, along with current policies encouraging standards that support more compact and efficient development, it is believed that there is merit in considering the requested rezoning to permit the proposed second unit above the proposed detached garage. This type of alternative housing permits family members to provide support for each other while also maintaining appropriate levels of independence. This is an alternative that will become increasingly necessary and common in the face of an aging population and limited, affordable alternatives. Accordingly, it is recommended that a public meeting be scheduled in accordance with the provisions of the *Planning Act* as a means to seek public input.

A public meeting to consider the proposed Zoning By-law amendment in accordance with the requirements of the *Planning Act* will provide an opportunity to hear concerns and comments, if any, of neighbouring owners and other interested stakeholders/agencies. It is important that the concerns and comments of these stakeholders be taken into consideration as part of the full evaluation of the applications.





And Whereas the Council of the Corporation of the Town of Tecumseh deems it necessary and in the best interest of proper planning to further amend By-law No. 85-18:

And Whereas the Provincial Policy Statement (2014) requires the remnant land from a surplus dwelling consent be zoned so as not to allow a residential dwelling on the remnant parcel;

And Whereas the Committee of Adjustment granted provisional consent to application B-08/18 for the creation of one surplus dwelling lot with a condition that the remnant lands be zoned so as not to allow a residential dwelling and to establish a minimum lot area for the retained parcel;

And Whereas this By-law conforms to the Official Plan in effect for the Town of Tecumseh for lands in the former Township of Sandwich South;

Now Therefore the Council of The Corporation of The Town of Tecumseh Enacts as follows:

- 1. **That** That Schedule "A", Map 13, to By-law 85-18, as amended, is hereby further amended by changing the zoning classification for those lands as depicted on Schedule "A" attached hereto and forming part of this by-law from "Agricultural Zone (A)" to "Agricultural Zone (A-30)".
- 2. That By-law 85-18, Section 15, Agricultural Zone (A) Regulations, as amended, is hereby further amended by the addition of a new subsection 15.3.30 to immediately follow subsection 15.3.29 and to read as follows:
 - "15.3.30 <u>Defined Area A-30</u> as shown on Schedule "A", Map 13 to this By-Law.

a) Permitted Uses

Uses permitted in the Agricultural Zone (A) as established in subsection 15.1.1, with the exception of the following uses which shall be prohibited:

- i) single family residential uses;
- ii) household occupation or agricultural household occupation;

b) Permitted Building and Structures

- i) Buildings and structures for the uses permitted in subsection 15.3.30 a);
- ii) Accessory buildings and structures for the uses permitted in subsection 15.3.30 a).

c) Zone Provisions

All lot and building requirements shall be in accordance with subsections 15.1.3 to 15.2.3, inclusive, of this By-law, with the exception of the following site-specific regulation:


