#### **6.4 COUNCIL REPORT** – Andrew Dowie reports on some of the items from two council meetings:

- Valente condo rezoning application was approved for 11870 Tecumseh Road
- Petretta Condos received their final approvals for site plan control
- A new development charges by-law was passed, and new fee schedule is below

- Council approved \$620k in allocating the MPF funding in a number of areas including
  - 0
  - Town Hall Expansion
  - Online property tax inquiry service
  - Cityworks Work Order Management
  - Water Oasis Payment solution
  - Online permit payment

- Briday developments (Old Victoria Public School) will be having an open house for the proposed Condo and townhome development for that property on September 10th
- Council also received the 6-month Transit report ridership and revenue are up slightly. The most notable change was the move of the Sobey's pick up spot to the new Food Basics.
- CIP funding request for 12222 Tecumseh Road for Parking lot improvements

#### 6.5.2 Membership Committee

6.5.2.1 Tecumseh Dollar Program – J. Champoux reports on the current Tecumseh Dollar report; see attached report. Due to the increase of Tecumseh Dollar purchases, there was discussion on the maximum amount that can be purchased by a person. The amount agreed for 2019 was to sell \$25,000 Tecumseh Dollars and the 20% discount will be a \$5,000.00 expense in the 2019 budget.

**THAT** the purchase of Tecumseh Dollars be increased from \$200.00 to \$400.00 per person per purchase be accepted and approved.

- **6.5.2.2** Board asks J. Champoux to create Facebook ads asking the public to use old style Tecumseh Dollars as they will become null and void as of December 31, 2019.
- **6.5.2.3** Coordinator has created a list of Members who do accept Tecumseh Dollars and distributes with map of BIA area with sales/donations of all Tecumseh Dollars.
- 6.5.2.4 Discussion on the outstanding Tecumseh Dollars amount was reiterated and confirmed that the current Tecumseh Dollar Program will be discounted as of December 31, 2019 and a new design, program, name will go into effect as of January 1, 2020. Reasonable notice will be given to the public that current Tecumseh Dollars that do not have a one-year expiry date will have until December 31, 2019 to use and Members to be reimbursed.
- **6.5.2.5** Associated Membership No report at this meeting.

### **6.5.3** Streetscaping Committee

- **6.5.3.1** BIA Parkette Memorial Bench On July 4<sup>th</sup>, members of Council, Town Administration, current and past Board Directors, BIA staff, family and friends attended the unveiling of the bench in the Parkette and Shoreline Tecumseh will publish a group picture and the article honoring both E. Tope and A. Baillargeon.
- **6.5.3.2** Bike Repair Stations Both repair stations have been installed and Coordinator asks Board for date and time to schedule an unveiling ceremony. It was suggested to contact Parks and Rec Manager on the date and time at McAuliffe Park for the unveiling of the new public restrooms.
- **6.5.3.3** Bike Racks 15 bike racks have been delivered. Public Works and Parks Managers are asking for exact locations for racks to be installed. Coordinator will contact all the Members who requested a bike rack and send pictures and description of each location to both Town departments for their consents to install the racks.

#### 6.5.4 Events Committee

- **6.5.4.1** Night Market Feedback from July Night Market extremely positive. Board recommends deferring the discussion on planning night markets for 2020 to the next board meeting.
- 6.5.4.2 BIA Christmas Party Date is Saturday, November 23, 2019 at Beach Grove Golf & Country Club. M. Kennedy has offered to sponsor the BIA at Beach Grove. Several suggestions for bands were provided and the Coordinator will request quotes.

#### 6.5.5 Office Relocation Committee

- **6.5.5.1** Lease Agreement The lease agreement for space at 12122 Tecumseh Rd. E. Unit #2 has been written and there are two items to update on the agreement; a cheque dated September 1, 2019 in the amount of \$2,000 will be submit to the landlord for first and last month two year lease.
- **6.5.5.2** It was recommended that a maximum of \$5,000.00 be allocated from the Reserve Account for the relocation move expenses.
- **6.5.5.3** Three insurance brokers have been contacted to submit quotes on content coverage (\$50k) and liability (\$2M) as well as the Town's insurer.
- **6.5.5.4** Current Property Owner has quoted \$6k donation to the BIA for conference table, chairs, TV, computer and desk; what has been left in the space the BIA is leasing is the conference table, 6 chairs, TV, computer and stand, bookcase and 4 desks.
- **6.5.5.5** It was recommended that the BIA obtain separate phone company and WIFI provider. P. Rorai contacted MNSi to purchase basic business package for same office and fax phone numbers. It was recommended for J. Champoux to obtain quote from Kelcom.
- **6.5.5.6** Move notices will be sent to all Members via email, Facebook, Twitter and an ad in the Shoreline Tecumseh.
- **6.5.5.7** Board agrees to purchase Trend Micro Security software, steel shelves for storage, additional chairs for conference table and a mini fridge.
- 6.5.5.8 After reviewing four moving company quotes; the Committee has chosen Hinton Movers.
- **6.5.5.9** A. Dowie informs that relocation date can be extended for an additional two weeks past August 29, 2019.
