Re: Town of Tecumseh Official Plan - Draft 1

The Director Planning & Building Services and Manager Planning Services present an overview of the proposed basis, goals and policies that will be contained in the future new draft Official Plan (Draft). The Director explains that the Draft is consistent with the Provincial Policy Statement and the County of Essex Official Plan. It is noted that there will

be an extensive public consultation process to provide comments and feedback on the Draft before it can be approved. The Director comments that the Provincial government has imposed new requirements to address demands such as affordable housing, the environment and climate change, which is reflected in the Draft.

Each section of the Draft is reviewed in a summary manner by way of a Power Point presentation and significant changes and new requirements are highlighted. The Director explains the next steps in the process, which is to distribute the Draft document to Council for review at a Council meeting in March.

The Mayor explains that this is the beginning stage of the legislated approval process and that the Draft is not being adopted at this meeting.

Council requests that Administration provide additional communication accompanying the tabling of the Draft for Council and residents to understand the major, high-level new changes proposed in the Draft from the current Official Plans, as well as summarize the significant Provincial requirements that the Town must be consistent with.

The Director indicates that it is proposed to have the Draft tabled at the March 24, 2020 Regular Council Meeting.
