Background


This Report summarizes the permits issued for the year of 2020 (January-March) and compares the values of the same period for the previous year. It is important to note that the Provincial Emergency regarding COVID-19 was declared March 17, 2020 and continues to be in effect as of the writing of this Report. As a result, construction activities have been restricted through various Ontario Regulations, however the processing and issuing of permits by the Town has continued as it is viewed as an essential workplace service by the Government.

1. Construction Value:


The following chart summarizes the reported construction value of permits for the period. Construction value was reported at \$5,206,667, which is up by \$742,114 or 17 percent over last year.





2. Number of Permits:

The following chart summarizes the total number of permits issued for the period. A total of 73 permits were issued, which is an increase of 15 permits or 26 percent over the previous year.



3. Permit Types:

The following chart summarizes permits issued by type for the period. A total of 4 new dwelling unit permits were issued, which resulted in 4 new residential units. For the same period last year there were 3 new residential units. There were 5 Backwater valve permits issued for the period in addition to a range of other permits as noted in the chart.
