# 1. Town of Tecumseh 2019 Citizen Satisfaction Survey

Re: CAO Update

CAO Margaret Misek-Evans reported that the date for the Essex County OPP's presentation to Town Council on the results of the 2019 Citizen Satisfaction Survey, as they relate to policing, is July 28, 2020.

#### 2. Excessive Noise - Vehicular Exhaust Systems

Staff Sgt. Jamie Smith presented his report to the board that summarizes a review of noise bylaws enacted in other communities and the options for enforcement in Tecumseh related to excessive noise generated by vehicular exhaust systems. CAO Margaret Misek-Evans also summarized the table provided by Administration that compares the noise by-law provisions of the cities of Windsor, Toronto and Edmonton, and compares them to Tecumseh in terms of enforcement, special equipment and whether they are complaint driven. She noted that these cities are much larger than Tecumseh, which only has one bylaw enforcement officer, who would face significant logistical and operational challenges to be precise on decibel levels both on the street and in court. Town Administration supports the OPP's recommendation to rely on the *Highway Traffic Act* as a first step in enforcement, and monitor how that unfolds. The Mayor noted that an enforcement 'blitz' could be helpful in sending a message to the community.

The Mayor expressed concern regarding illegal activities in the Carmelita Court neighborhood, where many seniors reside, including vehicles being broken into and/or damaged, and vandalism of properties. He thanked the OPP for their quick response to the resident who contacted the police, and suggested the warmer weather brings 'crimes of opportunity.' This would be a good time for a public "lock it or lose it" campaign. Chair Hales reminded all residents that the OPP is the first point of contact regarding such incidents.
