I. Communications - Action Required

Re: Court Security and Prisoner Transportation Transfer Payment Program Review - Communications to Ontario Police Services Boards

Inspector Miller explained that the OPP Municipal Policing Bureau has reached out to the Ministry of the Solicitor General to obtain clarification on what qualifies as court security during the COVID-19 pandemic, as procedures have been altered. He also confirmed that court security is not part of Tecumseh's contract, only prisoner transportation. Mayor McNamara added that the Association of Municipalities of Ontario (AMO) will be advocating for these expenses not to be downloaded from the province to the municipal level.

K. Old Business

1. OPP Contract Renewal

Re: CAO Update

CAO Margaret Misek-Evans noted that, because the *Community Safety* and *Policing Act, 2019* is not yet in force, a contract is still required under the *Police Services Act, 1990*. The current contract expires on December 31, 2020 and a draft agreement has been received from the Municipal Policing Bureau. It is largely the same agreement, but does include a new clause requiring one-year notice for the cancellation of any enhancements. The proposed contract will be presented to Council for consideration early in 2021. Chair Hales noted that it does not include any enhancements.

The Town's Director of Planning and Building Services, Brian Hillman, joined the meeting at this point (5:03 pm). He explained that the correspondence was referred to the board by Council at its November 24, 2020 meeting in order to obtain some insight from the OPP on their activities related to illicit cannabis operations. He noted that Council regularly receives resolutions from other communities in the province frustrated with the regulatory environment.

Inspector Glenn Miller noted the following:

- The OPP receives regular notification, typically on a weekly basis, from individuals and entities wishing to obtain a license from Health Canada to grow/produce cannabis. All requests are tracked by the OPP.
- Intelligence led policing is employed to ensure the individuals and entities involved comply with all laws. The Essex County OPP has a strong network of partners that assist in this tracking and observation.
- Investigations of suspected illicit operations can be long and complicated. While the public may have the perception of 'inaction', in fact the OPP is very engaged. A significant amount of illicit marijuana has been seized in this area.
- The criminal elements are growing in sophistication and often have multiple operations underway in different locations.

CAO Marg Misek-Evans inquired if there are steps the Town could take in its land use planning to forestall illicit operations. Inspector Miller responded that the Town's current legal framework is a good one, but the OPP will advance any observations and suggestions as they arise. The OPP and Town staff will continue this dialogue moving forward.

Mayor McNamara added that refinement in the federal legislation is needed. Even when municipalities strengthen their bylaws, producers take advantage of 'grey areas' in federal laws.

2. COVID-19 Pandemic - Enforcement Activity

Inspector Miller explained that, throughout the various stages of the COVID-19 pandemic, the OPP has been engaged in enforcement activity as directed by the provincial government, without any additional resources. He stated that the OPP has a good partnership with the bylaw officers in the various municipalities and will not hesitate to lay charges where it is appropriate. They are also tasked with doing follow ups on quarantine. He noted that both the OPP and Town bylaw staff now participate in the Town's Partial Emergency Operations Centre (EOC) meetings for enhanced communication and cooperation.

Brian Hillman, Director of Planning and Building Services, reported that Council passed a bylaw to empower three additional staff to issue tickets for bylaw infractions. A schedule of proactive enforcement has been implemented, including after-hours work. They are also coordinating with the Windsor-Essex County Health Unit (WECHU) for more proactive enforcement and participate in regular regional meetings with WECHU staff. He appreciates the support and coordination with the OPP to support Town staff in this role.

Mayor McNamara added that the WECHU has limited staff, who have been greatly taxed throughout the pandemic, and it is a significant support to them when such partnerships can move enforcement efforts ahead.
