Tecumseh Council at their Public Council Meeting held on March 9, 2021, adopted the Drainage Report prepared by Gerard Rood, P. Eng., of Rood Engineering Inc., dated April 3, 2020, for improvements to the Dawson Drain under provisional By-law No. 2021-15 (attached) in accordance with the *Drainage Act*.

Place: Electronic Meeting. Due to COVID-19 and restrictions on public gatherings, this meeting will be held in a virtual forum through electronic participation only. **There will not be an in-person meeting.**

The purpose of the Court of Revision is to hear any owner of land who wishes to appeal his/her assessment or any part thereof as set out in the Drainage Report. Any notice of such appeal is to be served in writing on the Clerk of the Town **at least ten (10) days before the meeting of said Court of Revision**. Notice shall be served at Tecumseh Town Hall at 917 Lesperance Road, Tecumseh, Ontario.
