Subject:	Cat Intake Program Renewal Agreement 2022		

#### Recommendations

It is recommended:

**That** The Corporation of the Town of Tecumseh **renew** the Agreement with the Windsor Essex County Humane Society (WECHS) for the provision of cat intake services, at a cost to the Town of \$25 for each cat;

**And that** the Clerk **be authorized** to execute the renewal Agreement between the Town and WECHS, for a further one-year term commencing January 1, 2022, and concluding December 31, 2022.

#### Background

The Cat Intake Program with the Windsor Essex County Humane Society (WECHS) allows residents to drop off stray cats to the WECHS at a cost to the Town of \$25 for each cat.

The Agreement with the WECHS for the Cat Intake Program has been in place since 2010 and was originally entered into following concerns expressed by Town residents regarding cats entering onto property other than that of their owners. The Agreement with the WECHS has been renewed each year since.

Upon drop off, the WECHS examines the stray cats for their disposition, and treats if medically necessary. Healthy and friendly stray cats are adoptable; stray cats that appear to be

community cats are spayed or neutered, vaccinated, micro-chipped and returned to the field where trapped to live out their lives without producing any more kittens.

# Comments

In just over the ten-year period, the Cat Intake Program has proven to be very successful for the Town and has received positive participation from residents.

A summary comparing the number of cats dropped off at the WECHS, over the past five years, is provided in the following Table.

As of July 31, 2021, the current cost to the Cat Intake Program is \$1,325 based on invoices submitted by the WECHS to the Town for payment.

Based on the historical trend in previous years, the months of July, August, September and October tend to have a higher rate of cat intakes.

There was a steady decline in the use of the Cat Intake Program experienced from 2017 to 2019, which may be attributed in part, at the time, to a decrease in the feral cat population and the positive participation in the Cat Spay and Neuter Voucher Program subsequently introduced in 2014. Both Programs were introduced to reduce the feral cat population.

The uptake in participation for the 2021 Cat Intake Program could be attributable to a build-up from 2020 COVID-19 closures which saw a significant decline in number of cat intakes.

The anticipated overage in the 2021 Cat Intake line item will be offset by Cat Spay & Neuter Voucher Program cost-savings in the 2021 P&I Animal Control Budget.

The proposed Agreement by the WECHS is consistent with participating area municipal agreements.
