Recommendations

Background

At the September 28, 2021 Regular Meeting of Council, the members received the Strategic Master Plan for Parks and Recreation Services, 5 Year Review and passed motion RCM-241/21 which reads as follows:

That Parks and Recreation Report No. PRS-2021-05, regarding the Strategic Master Plan for Parks and Recreation Services, 5 Year Review, be received.

And that the recommendations of the overall Strategic Master Plan for Parks and Recreation Services, 5 Year Review, be received.

And furthermore that Administration be directed to prepare a report for Council's consideration to adopt the Strategic Master Plan for Parks and Recreation Services, 5 Year Review.

Comments

At the September 28, 2021 Regular Council Meeting the members received a presentation from Bezaire Partners (consultant) that conducted the 5 Year Review. The consultant provided a summary of the review that consisted of:

- 1. Parks and Trail Inventory and Asset Valuation
- 2. Community Consultation
- 3. Benchmarking and Review of Recommendations from the 2010 Master Plan
- 4. Implementation

A summary of the recommendations and implementation strategies as recommended by the consultant is included in Attachment 1.

Administration is recommending that the recommendations from the Strategic Master Plan for Parks and Recreation Services, 5 Year Review be adopted and that Administration be directed to include operation and capital development initiatives in future municipal forecasts for Council consideration.
