### **Cyr Drain – Variation in Assessment**

Tecumseh Council at their Public Council Meeting held on September 28, 2021, deferred the adoption of the Drainage Report prepared by Mark Hernandez of Dillon Consulting Ltd., dated June 11, 2021, for the variation in assessment of the Cyr Drain under provisional By-law No. 2021-41 (attached) in accordance with the *Drainage Act*.

**NOTICE IS HEREBY GIVEN** that the **virtual meeting** for the Second Sitting of the Court of Revision in respect to the Drainage Report will be held as follows:

Place: Electronic Meeting. Due to COVID-19 and restrictions on public gatherings, this meeting will be held in a virtual forum through electronic participation only. **There will not be an in-person meeting.**

The purpose of the Court of Revision is to hear any owner of land who wishes to appeal his/her assessment or any part thereof as set out in the Drainage Report. Any notice of such appeal is to be served in writing on the Clerk of the Town **at least ten (10) days before the meeting of said Court of Revision**. Notice shall be served at Tecumseh Town Hall at 917 Lesperance Road, Tecumseh, Ontario.
