Staff Sergeant Jamie Smith provided a summary of the OPP Report for the months of October and November 2021.

Chair Hales inquired why the number of traffic stops was down. Staff Sgt. Smith responded that he is following up with officers to determine the cause. The OPP is transitioning to an e-ticketing system that captures every incident (including warnings), but the transition is not complete.

CAO Misek-Evans inquired why the number of false alarm calls was up. Staff Sgt. Smith explained that there have been a number of high wind events which may have contributed to this trend.

Mayor McNamara referred to the Auditor General's report entitled "Value-for-Money Audit: Ontario Provincial Police" released earlier in December and inquired how personnel shortages may be impacting the number of POA charges locally. Inspector Miller responded that some detachments are indeed short of personnel, with the issue being addressed at the Commissioner's level. He emphasized that all 911 calls in Essex County are answered immediately, and local detachment vacancies are gradually being filled.

**1. Mental Health Act - Definition of Apprehension**

Vice Chair Paul Sweet reported that some larger police services have been requesting their boards to support a change in the definition of apprehension under the Mental Health Act. Under the current legislation, this power only rests with the police, resulting in significant pressure on police personnel.

Mayor McNamara noted that, in his role as Warden of Essex County with responsibility for the EMS, it has become very evident that the mental health/opioid crises are interrelated and escalating, with frontline staff other than police very limited in the actions they can take. There are concerns for the safety of the first responders.

Chair Hales thanked the Vice Chair for raising this issue and indicated the board will watch for any resolutions circulated on this matter in order to give them due consideration for support.
