Subject: Essex Region Conservation Authority Transition Plan

Recommendations

It is recommended:

That Report CAO-2022-01, Essex Region Conservation Authority Transition Plan, **be received**.

Background

The Essex Region Conservation Authority (ERCA) recently completed its Transition Plan (Attachment 1), which was required for submission to the Province by the end of 2021. Recent amendments to the *Conservation Authorities Act* through Bill 229 now require each Conservation Authority to prepare transition plans and agreements for programs and services with each of its member municipalities. A key component of the new requirements is the separation of programs and services into mandatory and non-mandatory categories and alignment of their budgets accordingly. Following on this exercise, the final step is to enter into agreements or memorandums of understanding with municipal partners for the delivery of the non-mandatory programs and services. Conservation Authorities will no longer be able to levy for non-mandatory programs and services.

The attached plan outlines ERCA's Work Plans for Phase 1 and 2 of the Transition Period, which ends January 1, 2024. As indicated in the Transition Plan, there are points in the process where ERCA will confer with municipalities, including identifying a

liaison early in the process. The Transition Plan is provided for Council's information and awareness. Beyond the Transition Plan, the next deliverable is an inventory of programs and services, due by February 28, 2022.

Comments

ERCA has requested a primary contact at Tecumseh that ERCA can work with starting in 2022 as they finalize the Inventory of Programs and Services and commence negotiating Memorandum's of Understanding (MOUs). In consultation with ERCA and Administration on the expectations of the liaison role, Brian Hillman, Director of Development Services has been selected as the Town's liaison as the non-mandatory products and services are most aligned with planning.
