The following is provided as a result of our review of Zoning By-Law Amendment D19 6067WA. The purpose of the application is to amend Zoning By-law 85-18 by:

- i) Rezoning the 0.51 hectare (1.26 acre) non-farm related residential lot (6067 Walker Road), from "Agricultural Zone (A)" to a site specific "Agricultural Zone (A-34)" in order to establish a maximum lot area of 0.51 hectares (1.26 acres); and
- ii) Rezoning the 40.4 hectare (99.8 acre) agricultural parcel from "Agricultural Zone (A)" to a site specific "Agricultural Zone (A-35)" in order to prohibit a residential dwelling from being constructed.

## **DELEGATED RESPONSIBILITY TO REPRESENT THE PROVINCIAL INTEREST IN NATURAL HAZARDS (PPS) AND REGULATORY RESPONSIBILITIES OF THE CONSERVATION AUTHORITIES ACT**

The following comments reflect our role as representing the provincial interest in natural hazards as outlined by Section 3.1 of the Provincial Policy Statement of the *Planning Act* as well as our regulatory role as defined by Section 28 of the *Conservation Authorities Act*.

The above noted lands are subject to our Development, Interference with Wetlands and Alteration to Shorelines and Watercourses Regulation under the *Conservation Authorities Act* (Ontario Regulation No. 158/06). The parcel falls within the regulated area of the Oldcastle Road Drain and O'Neil Drain. The property owner will be required to obtain a Permit and/or Clearance from the Essex Region Conservation Authority prior to any future construction or site alteration or other activities affected by Section 28 of the *Conservation Authorities Act*.

### **RISK MANAGEMENT AND SOURCE PROTECTION PLAN**

The subject property may lie wholly or partially within the Event Based Area (EBA) of the Essex Region Source Protection Plan, which came into effect October 1, 2015. The Source Protection Plan was developed to provide measures to protect Essex Region's municipal drinking water sources.
