The following is provided as a result of our review of the Notice of Public Meeting to Consider Application for Official Plan Amendment D 19 HO OPA & ZBA, and Zoning By-Law Amendment. The purpose of the associated Zoning By-law amendment is to revise the current site-specific "General Commercial Zones (C1-2) and (C1-7)" that apply to the property in order to facilitate the installation of the proposed driveway access to Westlake Drive and establish site-specific lot provisions regarding the outside storage/display of products (i.e. sheds) and minimum number of parking spaces.

DELEGATED RESPONSIBILITY TO REPRESENT THE PROVINCIAL INTEREST IN NATURAL HAZARDS (PPS) AND REGULATORY RESPONSIBILITIES OF THE CONSERVATION AUTHORITIES ACT

The above noted lands are subject to our Development, Interference with Wetlands and Alteration to Shorelines and Watercourses Regulation under the *Conservation Authorities Act* (Ontario Regulation No. 158/06). The parcel falls within the regulated area of the Tecumseh Outlet Drain and Cyr Drain Outlet. The property owner will be required to obtain a Permit and/or Clearance from the Essex Region Conservation Authority prior to any future construction or site alteration or other activities affected by Section 28 of the *Conservation Authorities Act*.
