## NOTICE OF COURT OF REVISION MEETING

### **Drainage Act, R.S.O. 1990 c.D.17, s.52**

Tecumseh Council at their Public Council Meeting held on February 8, 2022, provisionally adopted the Drainage Report prepared by Mark Hernandez of Dillon Consulting Ltd., dated November 12, 2021, for the repair and improvement of the Antaya Drain (Drainage Report) under Provisional By-law No. 2022-005 (attached) in accordance with the *Drainage Act*.

You, as an owner of the land affected by the proposed drainage works for the Antaya Drain, are invited to attend a meeting of the Court of Revision to consider any appeals on the assessments set out in the Drainage Report.

The meeting of the Court of Revision in respect to the Drainage Report will be held as follows:

Time: 5:30 pm to 6:00 pm

Place: This meeting will be held in virtually and electronic participation only. **There will not be an in-person meeting.**

The purpose of the Court of Revision is to hear any owner of land who wishes to appeal his/her assessment or any part thereof as set out in the Drainage Report. Any notice of such appeal is to be served in writing on the Clerk of the Town **at least ten (10) days before the meeting** of the Court of Revision. Notice to the Clerk shall be served at Tecumseh Town Hall at 917 Lesperance Road, Tecumseh, Ontario or by email to [lmoy@tecumseh.ca](mailto:lmoy@tecumseh.ca)
