Environmental Scan – Policing in Ontario

- COVID-19 Pandemic
 - Delayed implementation of new policing legislation and reviews of grant programs (i.e. Court Security)
- New Policing Legislation
 - *Police Services Act, 1990 (PSA)* remains in effect for now
 - *Community Safety and Policing Act, 2019 (CSPA, 2019)* received Royal Assent on March 26, 2019 – regulations are still under development
 - Main changes that will affect local policing under *CSPA, 2019*:
 - Detachment Boards (transition expected in 2022)
 - Community Safety and Well-Being Plans
 - Changes to what constitutes police service
 - No more OPP police service contracts



Tecumseh Police Services Board

- Section 10 Board as required by the *Police Services Act*
- Board is responsible for the provision of 'adequate & effective police services' in the Town
- Current 5 member board:

Mayor	- Mayor Gary McNamara
1 Member of Council	- Deputy Mayor Joe Bachetti
1 Community Member (Council appointed)	- Christopher Hales (Chair)
2 Members appointed by Province	- Paul Sweet (Vice Chair) - Marc Gomes



2022 Budget Drivers

- 3 year contract expires at end of 2023 or earlier when *CSPA, 2019* comes into force;
- OPP wage adjustment has been included
 - OPPA Collective Agreement renegotiated in 2019 (to December 31, 2022)
- Maintain current service levels
- Impact of COVID-19 pandemic (board budget only)
- Impact of transition to OPP Detachment Board unknown at this time



Contract Services

- OPP contract is for 3 year term (2021-2023); contract eliminated if CSPA, 2019 comes into force sooner
- Cost allocation in contract is comprised of:
 1. Base Service (51.3%)
 2. Calls for Service (48.7%)
- OPP Wage (CBA)
 - 2020-22 – 2% average
- Billing reconciliation for 2022 in 2024

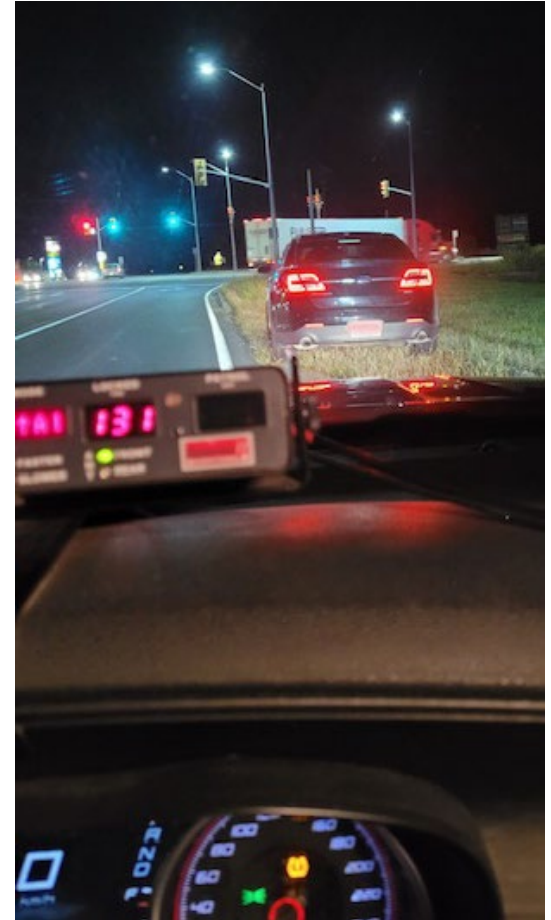

2022 Police Service & Related Initiatives

- Begin implementation of approved Community Safety and Well-Being Plan
- *Community Safety and Policing Act, 2019* – development of regulations
- Expected transition to new Detachment Boards
- Ongoing COVID-19 enforcement



POLICE SERVICES BOARD

Expenditures

- \$38,403 [2021 \$34,856], increase of \$3,547 or 10.18%
 - Increase of \$3,500 in Professional Development will restore a portion of training budget, which was significantly lowered in 2021 due to the COVID-19 pandemic.

The 2022 budget (\$7,100) recognizes the potential for some in-person events, but remains below the pre-pandemic amount (\$10,600).



POLICE

Revenues

- \$74,000 [2021 \$172,927], decrease of \$98,927 or 57.21%
 - Grants
 - Decrease of \$95,927 in Ontario Specific Grants.
 - The Community Safety and Policing (CSP) Grant is now applied to two rapid intervention programs oriented toward mental health & substance abuse calls
 - Funds cover transportation, phones, computers, training, and a portion of wages for HDGH counsellors
 - No offset for policing costs (wages)
 - Grant for Essex County OPP administered by Town of Kingsville
 - Fines
 - Decrease of \$3,000 in Parking Fines reflects actual activity



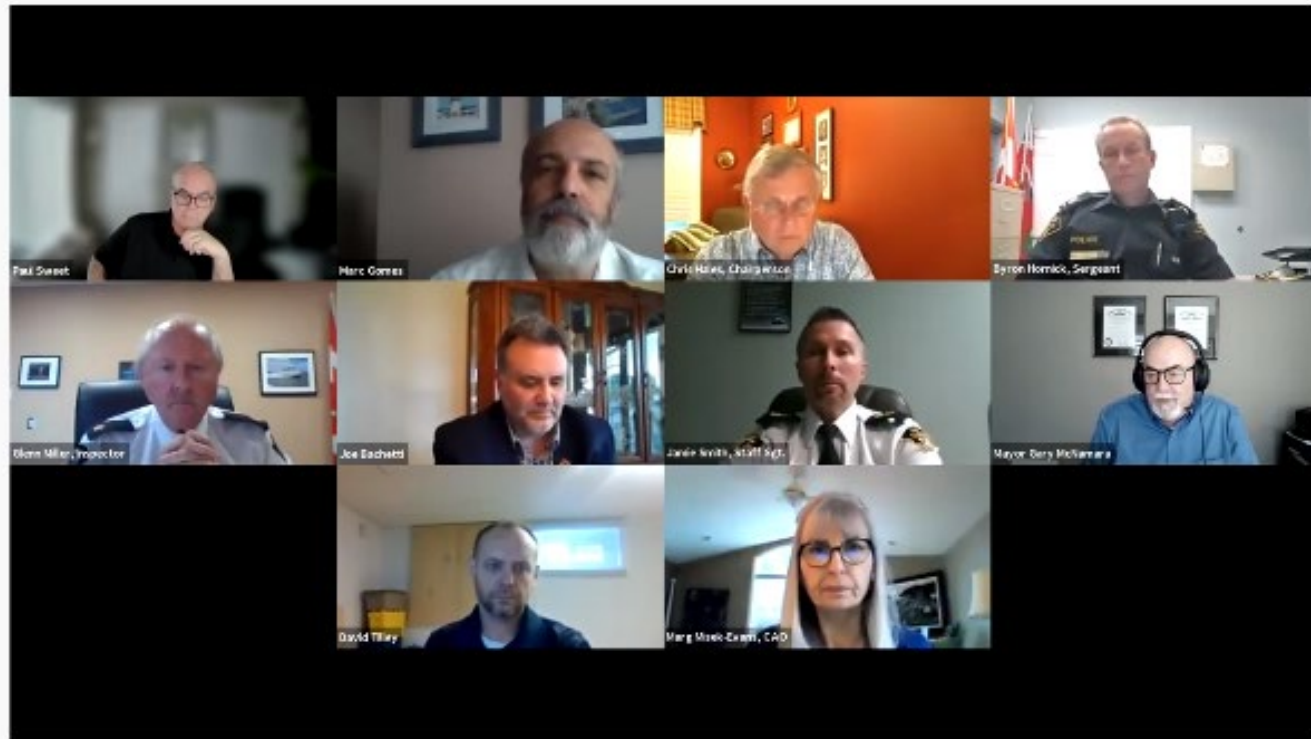
POLICE

Expenditures

- \$3,398,786 [2020 \$3,589,801], decrease of \$117,015 or 3.26%
- Contract
 - Gross expenditures in 2022 of \$3,404,548 vs \$ 3,523,602 for 2021
 - Decrease of \$119,054 or 3.35% reflects:
 - Credit for 2020 year end reconciliation
 - Overall lower cost per property (in both Base Service and Calls for Service)
 - Allowance for policing of special events
 - Wage adjustment for 2022

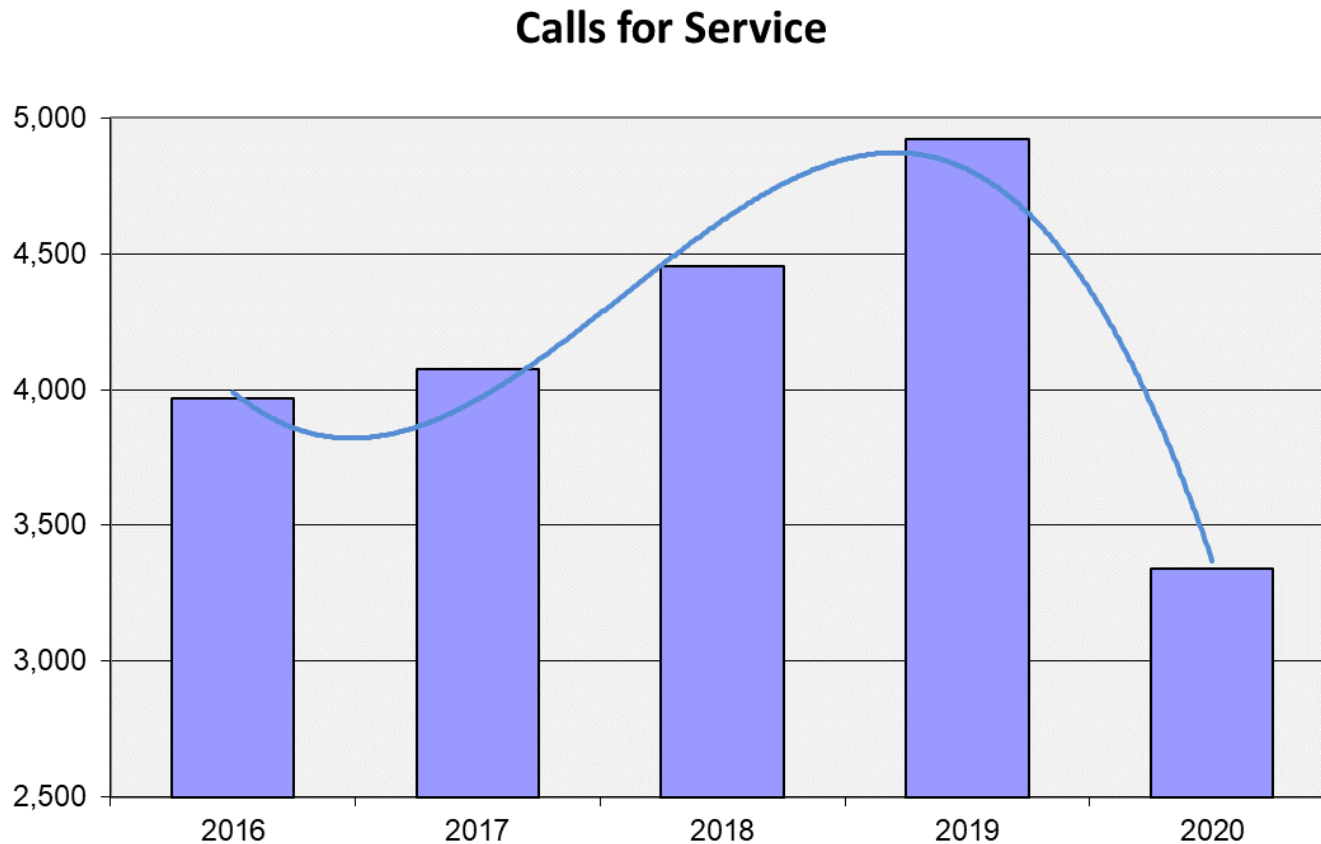

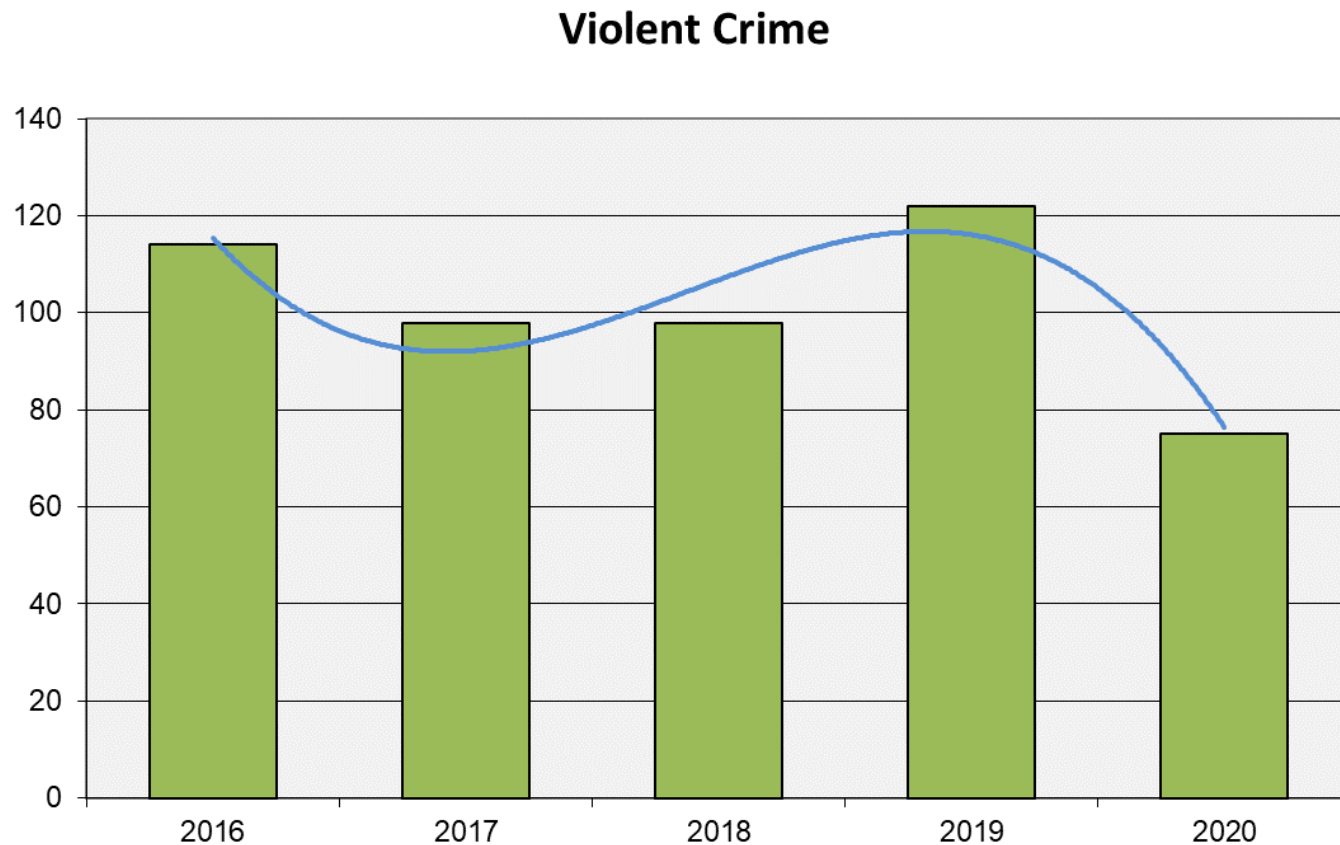

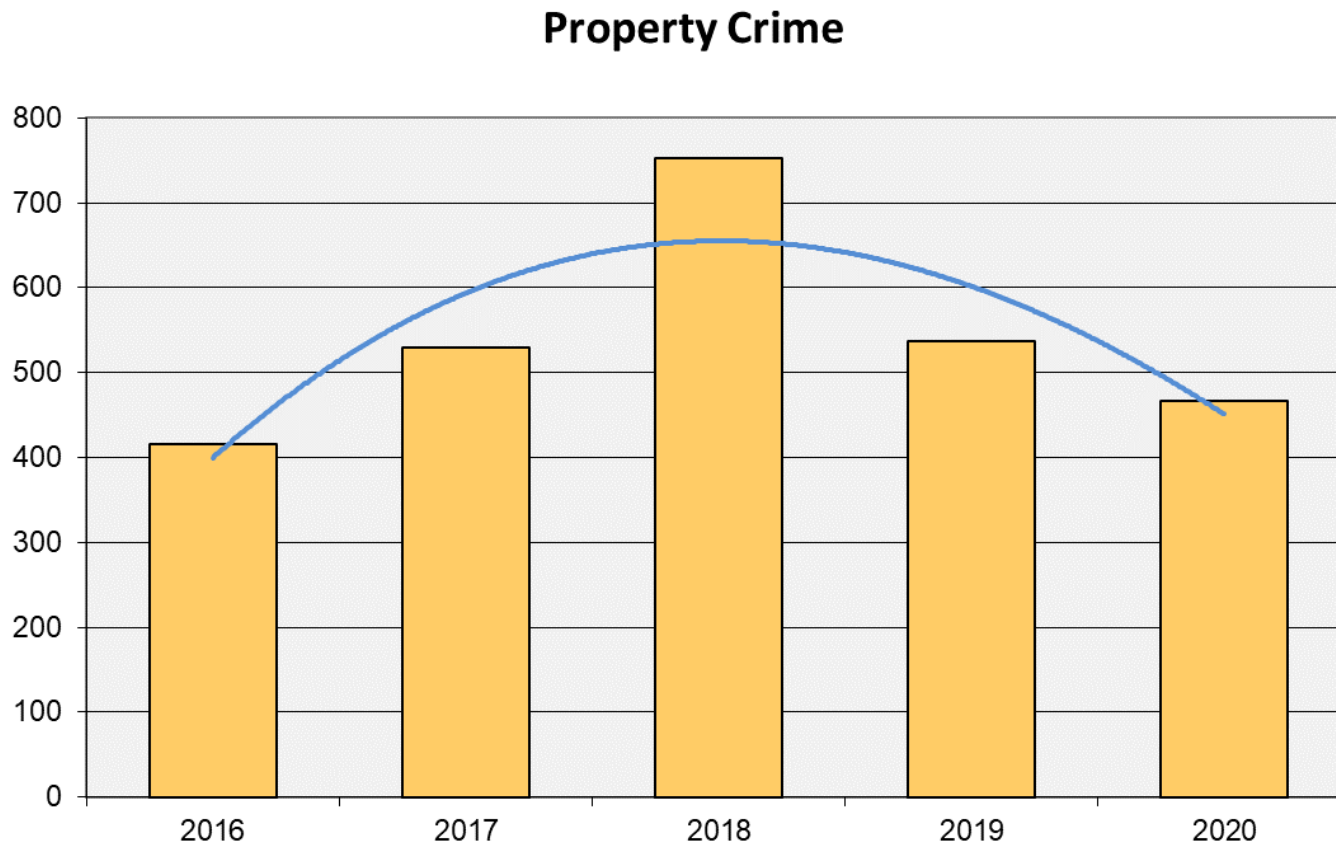
Appendix: Calls for Service Trends - Tecumseh Total Calls for Service
