Recommendations

It is recommended:

That the donation of the Surplus Fire Spartan Engine Rescue 1 (1990) to the St Clair College Pre-Service Firefighter Education and Training Program **be approved**.

Background

At the Regular Council Meeting of February 28, 2017, the members reviewed PWES Report No 03-17 and passed a motion (RCM-58/17), which reads as follows:

Spartan Engine Rescue 1 (1990) in the Fire department's fleet has been in service for 28 years as a front line rescue vehicle able to carry all specialized rescue equipment (ice and water, confined space and extrication equipment), as a fill in at both stations when a piece of front line apparatus is placed out of service, or when called upon in the case of a large fire.

Upon completion of inspections and outfitting of the new Rescue/Pumper, this apparatus will be placed out of service and disposed of according to Part VI, Disposal of Surplus or Scrap Materials and Equipment of the Town's Purchasing By-law, which states:

- a) All departments shall notify the Treasurer when items become obsolete or surplus to their requirements to ascertain if the items can be of use by another department rather than disposed of.
- b) Items that are not claimed for use by another department may be offered for sealed bids, public auction or other public sale, depending in the opinion of the Treasurer on which method is most suitable for the equipment or material involved.
- c) A major auction shall be held annually or as required dependent upon individual circumstances such as delivery of replacement items and storage capacity.
- d) The revenue from the sale of obsolete material shall be credited to the appropriate account.

#### Comments

The Pre-Service Firefighter Education and Training Program at St Clair College provides valuable training locally for potential Fire Service candidates. Tecumseh Fire Rescue Services along with other local Fire Departments have frequently hired graduates from this excellent curriculum, and Tecumseh's Chief and Deputy Chief are members of the Steering and Advisory Committee. The Surplus Spartan Engine Rescue 1 (1990), if donated, would provide valuable hands-on training apparatus for these students, greatly adding to the program by replacing an aging Engine in use from the College fleet.

In the past, the Town of Tecumseh has donated decommissioned fire equipment and apparatus to Fire Departments in need in the Dominican Republic and Namibia to assist them to provide their services.

It is therefore recommended that the surplus Spartan Engine Rescue 1 (1990) be donated to the St Clair College Pre-Service Firefighter Education and Training Program.
