**Re: County Road 11 & South Talbot Road Intersection Improvements
Request for Drainage Appointment – Oldcastle Road & Branch Drain**

Dear Mr. Bartnik

The County of Essex has retained the services of CIMA+ to undertake the detailed design for the County Road 11 (Walker Road) and South Talbot Road intersection. Improvements will include a modern roundabout to improve safety and operational efficiency. We anticipate that the improvements will impact the Oldcastle Road & Branch Drain on the east side of the intersection.

Through previous correspondence with your office, the County understands that N.J. Peralta Engineering Ltd. is currently appointed by the Town to complete a Section 78 Report, and that the Report is in the early stages of the process. For efficiencies, the County is requesting that the Town of Tecumseh revise N.J. Peralta Engineering Ltd.'s current scope of work to include coordination with CIMA+ for the County's works and incorporation of the final design of the drainage works into the Section 78 Report. The following are items that will be necessary from N.J. Peralta Engineering Ltd. in order for CIMA+ to complete the detailed design:

- Oldcastle Road & Branch Drain flow rates for the concrete culvert crossing South Talbot Road, on the east side of County Road 11;
- Confirmation as to the suitability of the proposed culvert location, orientation, size, invert elevations and embedment;
- Confirmation as to the suitability of the proposed revised drain alignment (horizontal and vertical);

- Input with respect to any design elements which may be required to be incorporated into the roundabout design to ensure the successful completion of Engineer's Report.

Through previous correspondence with your office, the County understands that Dillon Consulting Limited is currently appointed by the Town to complete a Section 78 Report, and that the report is ready to be brought forward to Town Council. In an effort to avoid delays associated with a scope change to the existing report, the County would like initiate a new Section 78 Report. For efficiencies and continuity, we would respectfully request that Dillon Consulting Limited be appointed by the Town to complete the Engineer's Report. We are requesting coordination between the appointed engineer and CIMA+ to complete these works and have the final design incorporated into the Section 78 Report. The following are items that will be necessary from Dillon Consulting Ltd. in order for CIMA+ to complete the detailed design:

- South Talbot-Holden Outlet & Branch Drain flow rates for the structure crossing County Road 11;
- Confirmation as to the suitability of the proposed culvert location, orientation, size, invert elevations and embedment;

- Confirmation as to the suitability of the proposed revised drain alignment (horizontal and vertical);
- Input with respect to any design elements which may be required to be incorporated into the roundabout design to ensure the successful completion of the Engineer's Report.
