A. Roll Call

B. Call to Order

The Mayor calls the meeting to order at 4:45 pm.

C. Land Acknowledgement

We acknowledge that we are on land and surrounded by water, originally inhabited by Indigenous Peoples who have travelled this area since time immemorial. This territory is within the lands honoured by the Wampum Treaties; agreements between the Anishinaabe, Haudenosaunee, Lenni Lenape and allied Nations to peacefully share and care for the resources around the Great Lakes. Specifically, we would like to acknowledge the presence of the Three Fires Confederacy Ojibwe, Odawa, Potawatomi and Huron/Wendat Peoples. We are dedicated to honouring Indigenous history and culture while remaining committed to moving forward respectfully with all First Nations, Inuit and Métis.

E. Introduction and Purpose of Meeting

The purpose of the meeting is to hear from any affected owner who wishes to appeal his/her assessment for:

- 1) **Demonte Drain** or any part thereof as set out in the Drainage Report, prepared by Dillon Consulting Limited, dated August 5, 2022; or
- 2) **Gouin Drain** or any part thereof as set out in the Drainage Report prepared by Dillon Consulting Limited dated January 20, 2023.

The Drainage Superintendent provides a background of the Drainage Report on the repairs and improvements to the Demonte Drain.

F. Delegations

- 1. Mark Hernandez, Drainage Engineer for Demonte and Gouin Drains
- 2. Walt Demonte, Affected Property Owner on Demonte Drain

Mr. Demonte objects to the costs of his assessment to the proposed the drainage works for the Demonte drain. He is assessed at 20 thousand dollars and indicates that there is no benefit to him at all.

Mr. Hernandez explains the drain improvements around the affected properties which has had significant consultation. The report as appended on the agenda, outlines improvements to get the drain back into working condition. He adds, a representative of Laval, an affected property, had expressed concern with respect to the bank stability and requested a closure of that section of the drain. The drainage report addresses the bank stability concerns by Laval and assessed half of the costs to Laval. The other half of the assessment is to the roadway which Mr. Demonte's property is affected.

The Chair inquires on the process for a closure of the drain and assessment. Mr. Hernandez explains the process and advises that the request is unique as the portion of the drain is located on Mr. Demonte's property and not Laval's.

The Chair explains the protection of the bank is the issue and these improvements will increase the longevity of the service of this drain. Mr. Demonte comments that Laval is causing the problem due to heavy traffic, and they should pay for it.

The Chair adds that he will take Mr. Demonte's comments under advisement.

3. Domenic and Guiseppe Viselli, Affected Property Owner for Gouin Drain

The Drainage Superintendent provides a background of the proposed works on the Gouin drain as outlined in the drainage report appended on the agenda. Mr. Hernandez advises on the communication item 2.e as appended on the agenda.

Mr. Domenic Viselli speaks on behalf of his father, comments on Schedule C of the assessment of his father's property. He inquires on the calculation used for the benefit and outlet assessments. Mr. Hernandez explains the process of assessments with respect to the type of land use, size of the property, and frontage. Mr. Viselli's property is larger than other properties assessed.

The Director Public Works & Engineering Services advises the timeline to appeal the Court's decision being 40 days from the date the notice was mailed out to the affected property owners. The third and final readings of the by-law will occur at the April 11, 2023 Regular Council Meeting.
