Staff Sgt. Jamie Smith presented the highlights of the OPP report, focusing on May 2023. He noted there has been a substantial increase in POA charges, and traffic enforcement has resulted in an average of 27 recorded vehicle stops per day.

Councillor Rick Tonial inquired about officers being available to conduct Joint Force Operation (JFO) traffic enforcement within Town streets. Staff Sgt. Smith responded that typically JFO enforcement is carried out in high volume traffic corridors, but if issues are identified, it can be carried out anywhere in Town.

Chair Hales inquired about the status of the bike patrol. Inspector Ferguson reported that training is complete and patrol teams are being assembled. Two officers would be needed for each patrol.

Chair Hales commended retiring canine Maximus and his handler on a very successful career and inquired if another dog is in training. Inspector Ferguson responded that this unit is managed at the provincial level, but the detachment can expect to see another canine purchased and trained in the future. Until then, other canine units in the province can be called upon for assistance.

Finally, Inspector Ferguson explained to the board that when the Community Safety and Policing (CSP) grant was applied for, Leamington was operating under Police Services Act S. 5.1 and did not qualify. Now that the municipality has a S. 10 board, it qualifies for a portion of the grant. The other municipalities' board chairs were requested to sign an agreement acknowledging this, and Chair Hales signed on behalf of Tecumseh's board.

#### 2. Other New Business

#### a. OPP Educational Programming in Schools

Chair Hales noted that at the OAPSB Zone meeting on May 26, 2023, there was discussion of PSBs requesting school boards to allow police access to schools for educational programming purposes. Inspector Ferguson explained that locally the OPP is still active in the Catholic school system, but in 2022 the Public school board conducted a review and decided to halt police programming in its schools (while all emergency protocols remain in place). Currently, the OPP is conducting its own review of interactions with youth in the community, through the University of Waterloo. Inspector Ferguson emphasized that all interactions with schools and school boards remain positive, officers continue to serve on committees and to look for resources to assist youth in the community.
