## 2. Indigenous Relations

Re: Beth Gignac, Director Community and Recreation Services

- Can-Am Indian Friendship Centre of Windsor and The Town of Tecumseh
- Objiway Anishinabe Learning Program: Pilot 2024

The Director presents the presentation entitled "Can Am Indian Friendship Centres" as appended on the agenda. She provides a background on Friendship Centres, guiding principles of the proposed agreement along with the roles of the Town and CIAFC. The agreement is drafted with the intention to build a relationship of mutual support. This is a two-year agreement with renewal options.

## 2. LCS-2023-33 Tecumseh Noise By-Law Review

The Director outlines the proposed revisions to the Noise By-law as presented in the way of a new by-law. He highlights some of the comments received by the Town in the public consultation remarks as appended on the agenda. He explains that temporary noise exemptions are still favored with an application fee as long as there are conditions in place (if applicable) to mitigate the noise emissions that are imposed and enforced. He notes in particular that enforcement concerns and issues were noted from the public consultation and that accordingly the new proposed by-law would provide for set fines and/or administrative penalties should Council approve the implementation of a Administrative Monetary Policy System in the future.

The proposed by-law as appended in Attachment 2, is outlined with the stated general intent that the sounds or "noise" that needs to be regulated are only those that are a nuisance as determined on a reasonable person basis. The proposed by-law has been drafted with greater application and flexibility with the appropriate discretion given to the by-law enforcement officer.

Other aspects of the by-law including the restrictions noted in Schedule A are reviewed. Residential areas are discussed along with motor vehicles on private property, excessive idling, animal noise that is persistent (being of ten minutes or more and/or over a period of one hour).

The delegation of authority to the Clerk to grant Temporary Noise Exemptions is raised. The Director highlights matters that should be taken

into consideration in granting exemptions including notification requirements, mitigation efforts and by-law enforcement officer monitoring an event, all of which will be at the discretion of the Clerk whose decision on the exemption request shall be final and binding with no further appeal to Council. Other factors that are considered in a temporary noise exemption application approval are: past infractions to noise by-law exemptions and mitigation measures proposed by the applicants themselves.

The Director adds that the by-law will be administered by the Clerk but enforcement will be through the Town's by-law enforcement officer and OPP.

The Mayor opens the floor to questions from the Members.

A Member inquires on enforcement of neighbour disputes regarding noise complaints. The Director responds that enforcement by either the Town By-law enforcement Officer or the OPP will depend on the hour of day and that what is or is not an acceptable level of noise will be at the discretion of the enforcement officer exercised reasonably.

A Member requests that an online Temporary Noise Exemption application be created.
