## **Background**

Community Living Essex County is a community organization that "celebrates inclusions and inspires possibilities." The organization was incorporated in 1961 and is now one of hundreds of Community Living organizations in Ontario serving people who have an intellectual disability. They are also part of a network of thousands involved in providing community living supports across Canada.

As a fully accredited organization they provide supports and services to over 700 children, youth and adults who have an intellectual disability and their families throughout Essex County. Programming includes supported community living options, employment supports and respite services.

The Town of Tecumseh has partnered with Community Living Essex County and is seeking their input as a member of the Wellness Hub planning committee that will bring more of their services to our residents. As well, the Town is currently exploring employment opportunities for individuals served by Community Living.

#### Comments

It is recommended that Council authorize the Director People and Culture to proceed with an application for a Corporate Membership with Community Living Windsor Essex to facilitate ongoing corporate membership.

The Corporate Membership is a Non-Voting membership meant for any corporation which supports the goals, purposes, and objectives of the Association. Benefits include invitation to the Annual General Meeting, highlight on their website, and ongoing communication from the organization.
