Background

Tecumseh Housing Advisory Panel

On June 25, 2024, by way of Report <u>DS-2024-21</u>, Council adopted the new Housing Advisory Panel Terms of Reference. The purpose of the Panel is to advise Council and Staff on the housing initiatives established in the Council adopted Tecumseh Housing Action Plan.

In addition, at the June 25, 2024, Council meeting, Councillor Higgison was appointed to the Panel, which also includes the Mayor as ex-officio. As outlined in the Housing Advisory Panel Terms of Reference, the balance of its membership comprises several local organizations and interests in the housing sector. The purpose of this Report is to recommend to Council appointment of the remaining members.
