**1. OACP/OAPSB Zone 6 Meeting - October 17, 2024 (Chatham, ON)**

Re: Chair's Verbal Report

Chair Paul Sweet reported on his attendance at the meeting held in Chatham, Ontario. Chatham-Kent Police presented on its hosting of the Special Olympics. The detachment board remuneration survey has been completed and is available on the website. The monthly drop in sessions are continuing and can also be accessed through the website. The 2025 spring conference will be hosted by London Police Service. OAPSB membership fees were determined using the same formula as OPP costing at \$0.21 per household, as noted in the draft budget being presented today. Membership fees for Zone 6 are set at \$300 and will be confirmed via virtual meeting following approval by this board. Ron LeClair, Police Services Advisor, complimented this board on its achievements thus far. He also advised that during the board training, a number of board members resigned across the province due to complexity of training.

## 3. 2025 Budget

Margaret Misek-Evans, Municipal Liaison - Tecumseh provided an overview of the 2025 draft budget, including relevant sections of the *Community Safety and Policing Act*: board remuneration; cost-sharing by the three municipalities; and what to do in event of a dispute. A summary is as follows:

- Budget for balance of 2024 - Municipal Liaisons reported directly to councils as the detachment board was unable to meet due to insurance. issues. Detachment Board budget was approved by the three municipal councils at \$70,113 plus an allowance up to \$5,000 for board insurance.
- Draft 2025 operating budget includes wages and benefits for members, support staff, and municipal liaisons, memberships, professional development, public relations, and insurance.
- The total annual operating budget proposed for 2025 is \$114,870 allocated equally between municipalities, except for costs associated with OMERS contributions for Tecumseh appointments, which are covered by Tecumseh.
- Draft allocations per member municipality are: Essex and Lakeshore: \$38,109.67 each; and Tecumseh: \$38,650.67.

Mayor Bondy requested consideration of a rotation for members wishing to attend Zone 6 meetings. The Chair advised this should be addressed in the governance policy which will be presented to the board.

Member Hales enquired as to how much involvement the detachment board will have in creating the OPP Annual Business Plan, as per the *Act*. Ms. Misek-Evans advised that the board will be consulted on the Local Action Plan which will be developed by the policing service.

The Vice Chair will present the draft budget to Essex Council on November 25, 2024 and the Chair will present to Tecumseh and Lakeshore Councils on December 10, 2024.

Mayor Bondy noted that Mary Birch, former Clerk for the County of Essex, has retired. She would like to know if Ms. Birch has been replaced and feels that a member of this board should sit at the Leadership Table. Ms. Misek-Evans will enquire about Mary Birch's replacement and also if Supt. Loucas has replaced former Inspector Angela Ferguson on the Leadership Table.

Mayor McNamara expressed his support of Mayor Bondy's recommendation, as did Member Hales.

Chair Sweet questioned whether the Leadership Table would be more on the administrative side. He offered to represent the Board on the Leadership Table, if appropriate.

Mayor Tracey Bailey questioned who holds terms of reference. Ms. Misk-Evans advised that the minutes are provided to City Council and County Council for approval, as they co-funded the Plan and its subsequent implementation.

Mayor McNamara advised that the Town of Tecumseh does a citizen satisfaction survey every two years which includes policing, and does not wish for duplication. Chair Paul Sweet suggested a consolidation of surveys for the three municipalities.

Chair Paul Sweet presented a list of grants available to communities for various policing programs, for the Board's information.
