# Recommendations

It is recommended:

That Report CRS-2025-06 Sport Operating Agreements be received;

And that the following by-laws:

- By-Law 2025-066 Tecumseh United Football Club;
- By-Law 2025-067 Windsor Wildcats Fastball Association;
- By-Law 2025-069 Tecumseh Minor Baseball Association; and
- By-Law 2025-070 Windsor Lady Expo Fastball Association,

**be considered** for first, second, third and final readings to authorize the Mayor and Clerk to execute Operating Agreements for a five (5) year term;

**And further that** By-Law 2025-071 St. Mary's Park Recreation Committee **be considered** for first, second, third and final readings to authorize the Mayor and Clerk to execute an Operating Agreement for a seven (7) year term with St. Mary's Park Recreation Committee; **And furthermore, that** Administration **be directed** to finalize and return the Operating Agreements with the Tecumseh Recreational Soccer Club and McAuliffe Park Sports for Council's consideration at the next Regular Council Meeting.

### Background

At the April 22, 2025 Regular Council Meeting, Report <u>CRS-2025-05</u> entitled "Community, Sport and Historical Society Operating Agreements" was received and resolution RCM 116/25 provided direction to Administration to bring forward a subsequent report for the remaining Sport Field User Groups and their respective bylaws to be prepared and presented for Council's consideration at this meeting.

The report provided a summary of the process used to develop the Operating Agreements as well as the value exchange criteria used to determine the financial implications of same.

## Comments

The intention of this report is to provide an overview of the Operating Agreements between the Town and Sport organizations who utilize the Town's sports fields for their activities and a summary of the specific financial relationships between the Town and the Sport organizations with financial implications.

The Sport organizations referenced in this report use the following sports fields:

### **Financial Implications**

As outlined in CRS-2025-05, the new Operating Agreements reflect a shift toward a value exchange model which recognizes the significant volunteer contributions, park usage, financial investments, and operational responsibilities provided by user groups.

This model replaces the legacy per-player fee structure introduced in 2013, which had remained static at \$5 per participant until Council approved an increase to \$10 in 2025 as part of the 2025 budget process.

Effective January 1, 2026, the Town will transition away from this flat-rate per-player system to a more equitable fee structure based on the value exchange model which assessed volunteer contributions, park usage, financial investments and operational responsibilities to determine a new fee.

The standardized five-year agreement term provides financial stability and predictability for both the Town and user groups, while the new model ensures alignment between service delivery, facility usage, and the Town's cost recovery goals.

The net financial impact to the Town is budgeted at \$38,000 in 2025 to \$45,500 in 2026 which represents an annual revenue increase of \$7,500 and a total revenue increase of \$37,500 over the 5-year period of these Operating Agreements.

#### **Summary of Operating Agreements**

The following section outlines the value exchange and projects annual financial contributions for each organization entering into an Operating Agreement. These summaries reflect a combination of fees, in-kind support, and historical or ongoing capital investments all of which form the basis of each group's unique financial relationship with the Town.

### **McAuliffe Park Sports**

McAuliffe Park Sports is entering into a five-year Operating Agreement based on a value exchange that reflects their level of activity, volunteer contributions, and capital investments. The group supports approximately 1,200 participants and delivers around 600 soccer and baseball activities annually, primarily for youth, along with one adult women's league. They contribute an estimated 5,000 volunteer hours each year. Based on this level of activity and community impact, their annual fee has been set at \$10,500 beginning in 2026. This represents a budgeted net decrease of \$750 before tax.

This group has also made notable contributions to Town infrastructure, including the McAuliffe Park Splash Pad. In recognition of their commitment and ongoing responsibilities including field maintenance & lining, shared scheduling, event setup/takedown and supply of activity specific equipment this agreement ensures continued access to fields, storage and concession space under clearly defined terms

#### **Tecumseh Minor Baseball Association (TMBA)**

TMBA is entering into a five-year Operating Agreement based on a value exchange that reflects their level of activity, volunteer contributions, and capital investments. The group supports approximately 350 participants and delivers around 2,000 baseball activities annually, with approximately 500 taking place on Town outdoor fields serving youth. They contribute an estimated 16,000 volunteer hours each year. Based on this level of activity and community impact, their annual fee has been set at \$10,500 beginning in 2026. This represents a budgeted net increase of \$7000 before tax.

This group has also made significant contributions to Town infrastructure, including contributions to outdoor washrooms/concessions at Optimist and Carling Park, numerous infield improvements, batting cage installation, fencing upgrades, and electrical infrastructure enhancements. In recognition of their commitment and ongoing responsibilities such as field maintenance and lining, shared scheduling, event setup and takedown, and the supply of activity-specific equipment this agreement ensures continued access to fields, storage, and concession spaces under clearly defined terms.

### **Tecumseh Recreational Soccer Club (TRSC)**

TRSC is entering into a five-year Operating Agreement based on a value exchange that reflects their level of activity, volunteer contributions, and capital investments. The group supports approximately 1,200 participants and delivers around 600 soccer activities annually, primarily for youth. They contribute an estimated 5,000 volunteer hours each year. Based on this level of activity and community impact, their annual fee has been set at \$10,500 beginning in 2026. This represents a budgeted net decrease of \$750 before tax.

This group has also made notable contributions to Town infrastructure, including the irrigation and field improvements at the Tecumseh Soccer Fields. In recognition of their commitment and ongoing responsibilities including field lining, shared scheduling, event setup/takedown and supply of activity specific equipment this agreement ensures continued access to fields and storage space under clearly defined terms.

#### Tecumseh United Football Club (TUFC)

TUFC is entering into a five-year Operating Agreement based on a value exchange that reflects their level of activity, volunteer contributions, and capital investments. The group supports approximately 400 participants and delivers around 2,500 soccer activities annually, with approximately 100 taking place on Town outdoor fields serving youth. They contribute an estimated 1,000 volunteer hours to the community each year. Based on this level of activity and community impact, their annual fee has been set at \$2,000 beginning in 2026. This represents a budgeted net increase of \$995 before tax.

In recognition of their commitment and ongoing responsibilities including field lining, shared scheduling, event setup/takedown and supply of activity specific equipment this agreement ensures continued access under clearly defined terms.

### Windsor Lady Expos Fastball Association

Windsor Lady Expos are entering into a five-year Operating Agreement based on a value exchange that reflects their level of activity, volunteer contributions, and capital investments. The group supports approximately 41 youth participants and delivers around 125 fastball activities annually on Town outdoor fields, in addition to numerous away games and indoor training sessions. They contribute an estimated 4,500 volunteer hours to the community each year. Based on this level of activity and community impact, their annual fee has been set at \$2,500 beginning in 2026. This represents a budgeted net increase of \$500 before tax.

This group has also made notable contributions to Town infrastructure, including the field and dugout improvements and batting cage located at Weston Park. In recognition of their commitment and ongoing responsibilities including field lining, shared scheduling, event setup/takedown and supply of activity specific equipment this agreement ensures continued access to fields and storage space under clearly defined terms.

#### Windsor Wildcats Girls Fastball Association

The Windsor Wildcats are entering into a five-year Operating Agreement based on a value exchange that reflects their level of activity, volunteer contributions, and capital investments. The group supports approximately 100 youth participants and delivers around 500 activities annually, with approximately 130 taking place on Town outdoor fields, in addition to numerous away games and indoor training sessions. They contribute an estimated 5,000 volunteer hours to the community each year. Based on

this level of activity and community impact, their annual fee has been set at \$3,500 beginning in 2026. This represents a budgeted net increase of \$500 before tax.

This group has also made notable contributions to Town infrastructure, including the field and dugout improvements. In recognition of their commitment and ongoing responsibilities including field lining, shared scheduling, event setup/takedown and supply of activity specific equipment this agreement ensures continued access to fields and storage space under clearly defined terms.

#### St. Mary's Park Recreation Committee

St. Mary's Park Baseball is entering into a seven-year Operating Agreement based on a value exchange that reflects their level of activity, volunteer contributions, and capital investments. The group supports approximately 650 participants and delivers around 350 baseball activities annually, which serves youth and adult leagues. They contribute an estimated 3,000 volunteer hours each year. Based on this level of activity and community impact, their annual fee has been set at \$6,000 beginning in 2026. This represents a budgeted net increase of \$0 before tax.

This group has also made significant contributions to Town infrastructure, including contribution to the Park's splash pad, numerous field improvements, fencing/dugout upgrades and field lighting enhancements. In recognition of their commitment and ongoing responsibilities such as field maintenance and lining, event setup and takedown, and the supply of activity-specific equipment this agreement ensures continued access to fields, storage, and concession spaces under clearly defined terms.
