The purpose of the meeting to consider the final report is:

- To have the Engineer present a summary of the Engineer's Report to Council.
- To consider the technical merits of the Engineer's Report (Culvert top width, culvert end treatment type, etc.)
- For Council to decide whether to; proceed with the project by provisionally adopting the Engineer's Report by By-law or; to refer the report back to the Engineer for modification.
- To give affected landowners an opportunity to provide questions, comments, or concerns before Council regarding the technical aspects of the Engineer's Report.

Please note that there is no right to appeal assessments or other aspects of the Engineer's Report at this meeting; these appeal rights will be made available later in the process, at the Court of Revision, which will be scheduled after the Consideration meeting.

Should you be unable to attend the meeting, it will proceed in your absence, and you will continue to receive notification of forthcoming meetings as required by the Drainage Act.
