Staff Sgt. Sakalo reported on the forum hosted by the OPP on February 7 on the topic of 'At Risk Youth and Human Trafficking'. There were 250 participants representing 43 regional agencies in attendance.

a. Board Membership - CAO Update

Following discussion, there was consensus not to move forward with regional discussions on board amalgamation until clarification on the legislation is received from the new provincial government.

a. Annual Performance Review of Detachment Commander

Similar to previous years, Chair Hales will compile a final performance review for the Essex County Detachment Commander with input from other board members.

b. Retirement of CAO and Board Secretary-Treasurer Tony Haddad

CAO Tony Haddad will retire at the end of March 2019, and this was his final meeting with the board. Chair Hales thanked Mr. Haddad for his expertise and years of support to the board. Mayor McNamara expressed appreciation to Mr. Haddad for the professionalism he brought to the board with respect to contracts, budgets and provincial initiatives such as OPP Billing Reform and Modernization of Policing. Chair

Hales presented Mr. Haddad with a donation to the Circle of Seven charitable organization, of which Mr. Haddad is President, as a show of appreciation.

c. Other New Business

CAO Tony Haddad reported that he had recently requested a report from the Tecumseh OPP Community Safety Officer on events and activities, which he summarized for the board. Deputy Mayor Bachetti noted that the CSO has been heavily involved in the schools and assisted with resolving issues that have come up.
