

THE CORPORATION OF THE TOWNSHIP OF SANDWICH SOUTH

BY-LAW 92-16

**being a by-law to provide for
maintenance to a drainage works in
the Township of Sandwich South
in the County of Essex
(Repair, Improvement and Extension
of the Cyr Drain)**

WHEREAS the Council of the Township of Sandwich South in the County of Essex, has been petitioned for the Repair, Improvement and Extension of the Cyr Drain.

AND WHEREAS the Council of the Township of Sandwich South in the County of Essex has procured a report (reconsidered) and specifications made by Bruce D. Crozier Engineering dated April 8, 1992.

AND WHEREAS the Council is of the opinion that the repair, improvement and extension of the drain is desirable.

THEREFORE THE COUNCIL OF THE TOWNSHIP OF SANDWICH SOUTH, PURSUANT TO THE DRAINAGE ACT, R.S.O. 1980, CH. 126 ENACTS AS FOLLOWS:

1. The report is set out in Schedule "A" attached to this by-law is hereby adopted and the drainage works as therein indicated and set forth is hereby authorized and shall be completed in accordance therewith.
2. The Treasurer, subject to the approval of Council, may agree with any bank or person for temporary advances of money to meet the costs of construction pending the completion of the drain and grants and commuted payments are received.
3. The Corporation of the Township of Sandwich South may issue debentures for the amount borrowed and the amount of such debentures shall be reduced to the total amount of:
 - (a) Grants received under Section 85 of the Drainage Act, R.S.O. 1980, Ch. 126;
 - (b) Commuted payments made in respect of land and roads assessed.
4. Such debentures shall be made payable within five (5) years from the date of the debenture and shall bear interest at a rate as approved by resolution of Council.
5. That all assessments of \$50.00 or less are payable in the first year in which the assessments are imposed.
6. That the Schedule of Assessment as established is adopted as listed in Schedule "B" of this by-law, which Schedule forms part of this by-law.


7. That the Specifications as established are adopted as set out in Schedule "C" of this by-law which Schedule forms part of this by-law.

8. That the Plan and Profile as established is adopted as set out in Schedule "D" of this by-law, which Schedule forms part of this by-law.


9. That the Reeve and Clerk are authorized to cause a contract for the construction of the works to be made and entered into with some person or persons, firm or corporation, subject to the approval of this Council to be declared by resolution.

10. This by-law shall come into force upon and after the final passing thereof when it is approved by the Ontario Municipal Board.


