Thank you for your letter and your interest in our government's Job Site Challenge program. I appreciate the time you took to identify prospective shovel-ready sites within the Town of Tecumseh

The Job Site Challenge is an important step in our government's plan to attract new manufacturing and investment opportunities to the auto sector. Thousands of Ontarians work in jobs that depend on the auto industry, and a new auto assembly plant — like the eight we already have in Ontario — will bring additional good-paying jobs to the community, as well as thousands of other good jobs at parts suppliers from across the province.

We have already heard from a number of Ontario municipalities that are interested in participating in the Job Site Challenge, and we expect to hear from more. We are now in the early phases of developing this program and additional details, including program intake information and next steps, will be shared with you as soon as they become available.

In the meantime, we can confirm that, as part of the selection process, we will be assessing prospective sites to determine whether they are suitable for the purposes of the Job Site Challenge, including how much effort and investment would be needed to obtain the necessary site approvals and servicing.
