a. Education Workshops

The Manager Committee & Community Services apprises Elder Abuse Prevention Ontario (EAPO), formerly Elder Abuse Ontario (EAO), is now offering a four-part lecture series that includes: Elder Abuse 101, Wellness & Prevention, Seniors' Rights and Legal Literacy and Healthy Relationships. This new series is being offered in addition to the various topics, including the It's Not Right Campaign, provided previously by EAO.

This workshop would also align with the proposed Seniors Community Grant Lunch 'N Learn series, subject to grant approval.
